- Starting to pull boats for the season, one boat will be kept on for response purposes and training. Mooring permits will go out Jan or Feb via email now that everything is done on-line. MA boater safety course will be offered in the winter (date TBD)
- On Waterway Regulations: Ed Y. and George M. reached out to Hingham and Hull to find out how/if those towns include MA-90B regulations in their town Regulations and provided input
- On how Weymouth handles 10-A permits: all done with paper(not on-line). Steps include filling out the application and blueprint describing 10-A request, then submit to Harbormaster, then permit is approved or denied.

- Plans and specs from Coastal Engineering will be ready for town to review by Dec 15 and there will be revised cost estimates as well. Goal is to get this out to bid in January, hopefully to start construction in fall 2023
