**Town of Weymouth
2010-2014 Five Year Consolidated CDBG Plan Draft**

From Wednesday, March 10, 2010 until Monday, April 12, 2010 the public is invited to submit written comments on the Town of Weymouth's *Draft 2010-2014 Five Year Consolidated Plan*, including the 2010-2011 Annual Action Plan, the final chapter of the Consolidated Plan.

The Consolidated Plan pertains to Community Development Block Grant ("CDBG") funds awarded to the Town each year by the United States Department of Housing and Urban Development ("HUD"). The Town's Department of Planning and Community Development ("DPCD") administers its CDBG program.

CDBG funds must be used primarily to benefit low and moderate income residents in the areas of housing, community, and economic development. The Town's Consolidated Plan identifies the needs of residents in the areas of housing, community, and economic development, and describes the strategies and objectives for meeting these needs over a five year period. Priority needs include infrastructure improvements, childcare and youth services, senior services, homeless services, severely disabled persons, housing programs, public housing, and economic development.

The Town anticipates receiving approximately \$879,523 in CDBG funds for FY 2010-2011. The Annual Action Plan chapter identifies the organizations and departments that will receive funding, the activity to be funded, and the CDBG fund amount.

Monday, April 12, 2010. Written comments will be considered and summarized as part of the final Consolidated Plan to be submitted to HUD no later than May 15, 2010.
