## WEYMOUTH ASSESSORS MEETING NOVEMBER 21, 2011

CHAIRMAN PAUL HALEY CALLED THE MEETING TO ORDER AT 7:00 P.M. IN THE KELLY ROOM AT TOWN HALL. THE FOLLOWING MEMBERS WERE PRESENT: PAUL HALEY, CHAIRMAN; KEVIN SPELLMAN, VICE CHAIRMAN; AND ROBERT BRINKMANN, CLERK.

SHE ALSO INFORMED THE BOARD THAT THE SALES AT WEATHERVANE ARE ELEVATING IN PRICE FOR BOTH NEW UNITS AND ON RESALES AS WELL. SHE SAID THAT THE VALUES AT WEATHERVANE WILL INCREASE FOR FY12 BY 4.5%.

THE BOARD REVIEWED THE INFORMATION BEING PRESENTED THIS EVENING AT THE CLASSIFICATION HEARING. MRS. PANTERMOLLER INFORMED THE BOARD THAT THE NEW GROWTH HAD BEEN APPROVED BY D.O.R. AND THE RECAP IS IN THE PROCESS OF BEING COMPLETED.
