A MOTION TO APPROVE THE MINUTES OF SEPTEMBER 12, 2016 WAS CALLED BY MR. SPELLMAN AND SECONDED BY MR. BRINKMANN. THEY WERE APPROVED UNANIMOUSLY AS WRITTEN.

THE CLASSIFICATION HEARING IS SCHEDULED FOR NOVEMBER 14, 2016 AT TOWN HALL. A DISCUSSION ON THE UPCOMING CLASSIFICATION HEARING ENSUED.

MRS. O'TOOLE INFORMED THE BOARD THAT THE 2017 VALUES HAVE BEEN APPROVED BY THE DEPT. OF REVENUE. SHE PRESENTED THE BOARD WITH A BREAKDOWN OF THE SHIFTS AT VARIOUS PERCENTAGES FOR THEIR REVIEW. SHE ALSO, DISTRIBUTED HANDOUTS OF THE HISTORY OF THE PAST SHIFTS AND A SPREADSHEET FOR FY 17 TAX RATE IMPACT.

AFTER MUCH DISCUSSION, A MOTION WAS MADE BY MR. BRINKMANN AND SECONDED BY MR. SPELLMAN AND SO VOTED UNANIMOUSLY "TO RECOMMEND TO THE MAYOR AND TOWN COUNCIL A 45% SHIFT FOR CLASSIFICATION PURPOSES AND THAT NO RESIDENTIAL EXEMPTION BE IMPLEMENTED FOR FISCAL YEAR 2017."
