APPLICATION OF **1622 MEDICAL LLC** FOR A MEDICAL MARIJUANA TREATMENT CENTER LICENSE (MTC) FOR THE BUILT LOCATION OF 1381 WASHINGTON ST.

Mr. Stephen Ganley, Manager of 1622 Medical LLC, introduced himself and he was present with his representative Walter Sullivan.

Acting Chairman McCormack stated it has been five years since they have met and started this proposal. They will allow this opportunity for 1622 Medical LLC to discuss it further.

Mr. Ganley introduced himself as the manager of 1622 Medical LLC and stated that he submitted the MTC application for the Licensing Board's approval. The application included security, building and operation details. The agreement has been in place with the Town since 2018.

Mr. McCormack stated over the years, they never had the community meetings for an explanation of the process and how it would be set up.

Mr. Richards stated that the application is for a specific address to be built in town, and it is the only license to be issued. It is for medical marijuana only.

Mr. Sullivan said they went before the state through the process. Today's application is for a conditional license rather than a provisional license, so that they may take the next step before the state to build the site, subject to a Certificate of Occupancy by the town. The Cannabis Control Commission (CCC) will also inspect the site for specific requirements. The site of 1381 Washington Street would be built as a cultivation facility and a dispensary for the manufactured products in the form as medical marijuana. Customers would require a valid medical marijuana identification card. Product would be sold only in a 60-day supply.

Mr. McCormack stated he would like to have a community meeting to disseminate information about safety measures and how the building will be set up in regulation of the medical marijuana. The Town's policies and procedures will be updated to be consistent with CMR 935 501.000.

Mr. Sullivan added that the facility design for the dispensary would be similar to the Curaleaf business in Hanover. There would not be many people coming in and out at a time as it is doctor prescribed. Proposed site plan has 19 parking spaces. Mr. Sullivan stated when they submitted the application and plans originally there was no requirement to host a meeting.

Mr. Richards said the hours would be 7 AM - 7 PM and Sunday: 10 AM - 6 PM. He asked Mr. Ganley for more details about the building.

Mr. Ganley stated the building and site plan may change. They are requesting for a conditional license approval today. Building development would be subject to Building Permits, inspections and a Certificate of Occupancy. The CCC approval requires a State architectural review of the plans and security regulation; State Statute driven in relation to medical marijuana.

Mr. Richards called Mr. Robert Luongo, Planning Director, to review the site and address for the

proposal.

Mr. Robert Luongo said the site was formerly owned by Bristol Lorusso. An ANR plan was submitted dividing a paper lot into two lots, one with a mixed-use building, leaving the other lot. There was some confusion; Mr. Bristol has filed with the Planning Board a sub-division plan for the entire parcel. Ten acres is the Hanover Properties site and the other ten acres will be for the MTC Treatment Center. The application has been continued by the Planning Board to be heard in February or early March. The ANR plan is in place.

Mr. Richards stated zoning would be approval by right.

Mr. Luongo affirmed and said the parcel is located in the I-1 zone, suitable for medical marijuana, within the commercial overlay district.

Mr. Richards after hearing deliberation made a MOTION to approve the MTC Medical Marijuana Treatment Center License application for the location of 1381 Washington Street as a Conditional License, with the following conditions:

- 1. Town of Weymouth Departmental Review and Inspections by: Building, Fire, Health, Conservation, Police DPW, Planning departments
- 2. Zoning provisions; traffic
- 3. Compliance with the Town of Weymouth Ordinances
- 4. Compliance with the Cannabis Control Commission Regulations and CMR 935
- 5. Stipulation of a maximum of 5,000 sf grow area
- 6. Annual Review of the Host Community Agreement and License Renewal
