Mr. MacLeod stated what is happening is two agencies are trying to work together and trying to put this beach boardwalk program together but the difficulty is more with the two agencies working together. There are issues with the handicap ramp being too close to the beach because it's not good for the beach.

- Elevators now during daily announcements they say anyone using elevators without a pass will be punished.

Chairman Goldman stated he has suggested in the past to remember the elevator use policy.

Mr. MacLeod suggested Chairman Goldman call the Vice Principal and Principal and make an appointment and come in and discuss the issue; also offering to help facilitate making the appointment.
