

### School Building Committee Update:

Mr. MacLeod said most of the town's focus has been on COVID and schools reopening. He said the building is on schedule; they will be doing pressure testing the week of March 7<sup>th</sup> and expects to see binder pavement in June/July.

#### **Old Business:**

- Ms. McDonough asked for any website disability information to be sent to her.
- Ms. McDonough said most complaint calls are regarding apartment complexes; they should be calling the Mass. Office on Disabilities (it is out of Weymouth's hands).
- Chairman Goldman said, over the next 12-18 months, the Commission should focus on providing resources.

## **New Business:**

- Review of Social Services Reference Guide:
  - COVID information has been received
  - Information on veterans is still needed.
  - Disabilities page on town website is outdated.
- Chairman Goldman said, as a commission, COD needs to decide what role it will play.
- Ms. McDonough suggested that COD become more familiar with disabilities beyond what they already have for specialties; members present agreed.
