 Demo and rebuild single-family home

Brad Holmes is on the video call to present together with Tayson Ng the owner. This is a reconstruction of a dilapidated single-family home within the Buffer Zone to Whitman's Pond, within River Front Area and Bordering Land Subject to Flooding. He described where they are with this project since it was presented last summer to the Commission. Mr. Holmes did define this as a demolition and a rebuild.

Ms. Schloss recommends the following conditions:

- Standard Conditions
- Construction period dewatering with standard and specific language in preconstruction meeting
- Riverfront Mitigation 754 sq ft. of an area to include:
 - Removing the turf
 - · Conservation seed mix
 - Six saplings
 - Fourteen shrubs
 - Meet with the hired Professional Wetlands Restoration, Brad Holmes before/or during the restoration work. Be present on site as work starts
 - May need additional erosion controls, leaving flexibility for this
 - A schedule of the project
 - Two Year monitoring of the mitigation plan with an annual report
 - Request for vista pruning, maybe combined with mitigation plan

A Motion was made by Cmmr. Loring and seconded by Cmmr. Singleton to close the public hearing.

Ms. Schloss recommends the issuance of an Order of Conditions (OOC) together with the special conditions mentioned here tonight.

Michael Rota was on the call to present and states he is looking to prune the trees along the perimeter of the property with 3 or 4 to be taken down completely. The roots are starting to get under the parking lot over the past 10-15 years.

Mr. Hultin who had an on-site visit with the applicant and went over the area as follows:

- · Two dozen trees that need pruning
- Three are proposed for removal
- Standard tree removal conditions
- Trees to be cut at ground level
- Stumps not to be ground out
- No machinery to be used beyond the pavement

Gabriel Padilla with Grady Consulting was on the phone to represent Joan Horner. Ms. Horner is the homeowner and has issues with ponding in her backyard which runs along the edge of the

wetland. They are proposing to build a retaining wall and raise the level of the backyard. He continued in detail the plans that were shown to the Commission and public.

Christine Perron, and Steve Hoffman with the consulting firm McFarland Johnson were on the call to present. Christine also introduced Kirk Ryden from Appledor Marine Engineering who was also on the call. They are proposing on behalf of the USCG to replace 5 aids to navigation in Massachusetts Bay and the one they are speaking of tonight is located in the Weymouth Fore River. They are all located in different municipalities. This will be a replacement of an existing channel light structure and they went through the details of how the work will be completed.

Mr. Hultin and Ms. Schloss recommend that:

- This item be continued until the commission receives comments from the Division of Marine Fisheries
- The Best Management Practices noted in the NOI application be incorporated into the Order of Conditions

Sean Sullivan was on the call to present. He would like to install a fiberglass 12 x 25ft pool just outside the wetlands. He will be using a cartridge filter and saltwater system as to not harm the environment.

Mr. Sullivan sent a revised plan for the Commission to review showing the pool further away from the slope due to concerns over the slopes stability.

A Motion was made by Cmmr. Loring and seconded by Cmmr. Donovan to close the public hearing.

Mr. Hultin recommends issuing an Order of Conditions (OOC) with Standard Pool Order of Conditions, together with a condition to move the shed.

A Motion was made by Cmmr. Donovan and seconded by Cmmr. Loring to issue the Order of Conditions with the Standard Pool Order of Conditions and a provision for moving the shed.

10. Other Business

Ms. Schloss announced she will be getting in touch with people for required signatures of documents.

11. CPC Update

Cmmr. Loring reports that they finally had a meeting. The Whitman's Pond Wheat Management Study was funded for \$18,750 ESS Group finally submitted final draft to Ms. Schloss and should be posted on the Town's Website soon.

The Pedestrian Bridge over the Herring Run to Lovell Playground was funded for \$182,341. The Town recently received the Chapter 91 License.

Back River Trail, Route 3A entrance was funded for \$77,428 and project is completed.

Land Acquisition For Open Space was funded for \$100,000 with no properties being acquired yet.

12. Herring Run Update

Cmmr. Loring reports they are getting ready for the season. They were out cleaning up debris up at Iron Hill and keeping an eye on things making sure everything is ready for the Herring.

13. Conservation Report

New Projects:

200 Libbey Parkway the Children's Hospital project is going to be starting shortly. Pre-Construction meeting happening shortly and the same for the **655 Washington Street**, Boston Motel will also be starting up.

109 Regatta Road site meeting this morning and met with the Construction Company who stated they could not start this job now. Ms. Schloss recommended that the file a notice of intent since this started back in August where the slope collapsed. The emergency certificate expires September 2 and they need to come in next meeting for Slope repair and Septic repair.

Route 18 widening – there are between 20-25 trees to be planted in the Front Street area and maybe looking at more trees to be planted in the area. We can argue with mitigation with MASDOT over the tree that has to be removed.

MASDOT project at Neck Street - where the new manholes were constructed for inflow and outflow in the saltmarsh. The trash rack was installed on that, when our OOC asked for opening be no smaller than 6 inches square per Ed Reiner at the EPA. They have been measured and are 4 inches square. It will pass small fish, but may want to put on a future Agenda. There is a two year monitoring period for this project.

Pleasant Street Billboard - Mr. Hultin was present during the recent sediment removal work.

19 Perkins Road project at the end of South Cove was an OOC for a garage and a swimming pool that have been construction. There was Mitigation planting plan for 16 shrubs to be installed along the pond and a fence has now been installed so the plantings would have to be on the lawn side, instead of the pond side which was not the intention. The Commission indicated they want the applicant to come into a meeting and put it on agenda. Ms. Schloss will get in touch with them and invite them.

Compliance Enforcements and Complaints:

Debris behind Shaws- property owner has indicated the trash ahs been cleaned up and that they are willing to install a fence to prevent future trahs from entering the wetland.

Whitman's Pond Vegetation Management a final report has been done. There is going to be a Notice of Intent NOI filed sometime this spring.

Iron Hill Park Feasibility Study and Conceptual Designs had their second Community Meeting on December 9th there will be another meeting with the date to be determined.

Snup Dam removal – good kickoff meeting. DER is going to hire a contractor to conduct a feasibility assessment and cost assessment. They will be doing some sediment samples.

Arbor Hill Conservation Restriction has been signed by the Executive Office of Environmental Affairs and will be recorded soon.

Plymouth River flood study The town will be applying for FEMA funding to study the flooding issue

Upcoming Opportunities:

MACC has their Winter Confer March 1-12 to be held remotely. Let Ms. Schloss know if anyone wants to attend.
