Chairman Smart reported that this is the final step to accepting the seven streets listed as public ways. He asked Solicitor Lane to give a brief overview of the process.

Solicitor Lane reviewed the steps: the initial petition was filed in the Town Clerk's office. The abutters were notified, public hearings held, applications reviewed by the Town Council, Planning Board and Ordinance Committee. These were referred to the DPW for waivers. Input was heard from the abutters in public hearings. The approval by the Planning Board was affirmed. To complete the process, the Council will take acceptance by approving in three parts: the adoption of taking, the acceptance of waivers and the acceptance of streets. The wall and capstones repairs that was brought up by an abutter at the public hearing, are scheduled to be done.
