Any forms that are not completely filled out will **NOT** be accepted. **NOTE:** Income information **MUST** be supplied on **ALL** persons living in the household who are 18 years old or older whether related to you or not!!! Awards amounts will be available March 26, 2010. All awards must be used for in-person registration or drop-off registration (new). Registration between March 29 – April 09, 2010 requires a utility bill and photo ID with address as proof of residency.

The following household information must be stapled to this application in order to process:

1. A copy of your 2009 Federal Tax Forms #1040 for all filing residents of household or your 2008 Federal Tax Forms #1040 plus three (3) current consecutive pay stubs for each person 18 years of age or older in the household. All such persons **MUST** be identified on opposite page.
2. Documentation of any additional income not reported above – alimony, social security, rental income...



Program scholarships are funded by the Town of Weymouth's Community Services Account. They are intended to benefit low and moderate-income residents. Children ages 3 – 16 are eligible.

Scholarship awards will not have to be matched and they can be used from March 29, 2010 through December 31, 2010.
