Biographical / historical note:

Dr. Noah Fifield (1783-1867), son of Ebenezer and Mary Sanborn Fifield, was born in East Kingston, NH. His parents later moved to Readville, Maine. He studied medicine with his uncle Dr. William Sanborn of Falmouth, ME, and Dr. Nathan McKinstrey of Newbury, VT. Fifield attended medical lectures at Cambridge, MA in 1804 and settled in Weymouth in 1806. He became the protégé and friend of Dr. Cotton Tufts. Fifield maintained a large and successful practice in Weymouth and surrounding towns for more than sixty years. He was an original subscriber to and a clerk of the Society for the Reformation of Morals, founded in 1811.

Hannah Cranch Bond Fifield (1787-1870), daughter of William Bond and Hannah Cranch, was born in Falmouth (near Portland), ME. Her father was a watch and chronometer maker. Her brother William Cranch Bond (1789-1858) became the first director of the Harvard College Observatory.

Married in 1820 or 1821, Noah Fifield and Hannah Cranch Bond Fifield had three children: George Fordyce Fifield (1822-1846). He died while attending Harvard College.

Mary Sanborn Fifield (1824- 1845). She died of an unnamed illness. Along with her mother, Mary Sanborn Fifield was a member of the Boston Female Anti-Slavery Society and friends with Maria Weston Chapman's younger sisters Emma, Anne, and Lucia Weston.

William Cranch Bond Fifield (1828-1896). He followed in his father's footsteps and became a physician. He was a graduate of Harvard College and furthered his medical studies in London at the Royal Academy of Surgeons and Paris. He married Emily Anna Porter (1838 (or 1840?) -1913) in 1856 upon his return from Europe. Rev. Jonas Perkins of the Union Religious Society of Weymouth and Braintree performed the wedding ceremony.

Emily Anna Porter Fifield's parents were Thomas Bradstow Porter (1808-1895) and Emily Vining Porter (1814-1888). Thomas Bradstow Porter, son of Lebbeus Porter and Polly Bradstow Porter, was a descendant of Richard Porter who settled at Weymouth in 1635. Porter became a lumber merchant and was prominent in town affairs, serving as a selectman and assessor.

Emily Ann Porter Fifield's siblings were:

- Susanna Bigelow Porter (1842-1871)
- Mary Fifield Porter (1845-1872)
- Jenny Frances Porter (1850 -1886)

Emily Porter Fifield was an active member of the Boston School Committee for 17 years, and the second woman ever elected to the Committee. During her term (1883-1902) she was instrumental in establishing manual training in the schools.

She was prominent in philanthropic, religious, and educational work, and served on several state and municipal boards. She made a special study of school conditions in all parts of the county. A Unitarian, she was recording secretary of the National Alliance, which was the leading women's organization of the Unitarian churches in America.

The couple had three children:

Mary Sanborn Fifield (1857-1941). She and her mother were the collectors of the Fifield family's historical materials. The initial donation to the Tufts Library occurred while Emily Porter Fifield was alive. Mary Sanborn Fifield King continued making donations into the 1930s. Nothing is known about her education or found about her two husbands. She married Sylvanus F. Freeman in 1875 according to Google books (1901 Bio sketches of prominent MA) and, sometime before 1911, Henry B. King.

The two sons, George Fordyce Fifield (1859-1860) and Charles Bell Fifield (1861-3/4/1877) died before their majority.

Scope and Contents: The Fifield Family Collections contains correspondence, personal papers, ephemera, photographs, and artifacts including textiles and jewelry created or collected by three generations of Fifield family members.

The Collection has four series: Correspondence, 1826-1923, 0.5 li. ft.; Personal Papers and Ephemera, 1811-1926, n.d., 2.0 li. ft.; Photographs, 1864-1910, n.d., 1.0 li. ft.; and Artifacts, 1830-1888, n.d.,

Series I. Correspondence, 1826-1923, has been arranged by recipient, beginning with the earliest generation, and then in chronological order. The more significant correspondence as it relates to social and human rights movements, especially anti-slavery efforts, can be found in Hannah Cranch Bond Fifield's and son William Cranch Bond Fifield's letters. Many letters addressed to Hannah Fifield in her role as secretary for the Weymouth and Braintree Female Anti-Slavery Society have been conserved by Northeast Document Conservation Center. They have been integrated into the arrangement; those that have been conserved are noted in the container list and on the individual folder.

There are fourteen letters to Mary Sanborn Fifield and one to George Fordyce Fifield, two of

Noah and Hannah Fifield's children who died in their early 20s. The letters to Mary include mentions of the Weston sisters, the younger sisters Lucia, Emma and Anne being among Mary's friends. There is a single letter from Anne Weston *re* the anti-slavery bazaar preparations.

The only surviving child, William Cranch Bond Fifield's letters include more information about the anti-slavery movement, especially when after Harvard he went to London and Paris to continue his medical education to become a surgeon. He served as a go-between in getting packets of literature to various abolitionists. There is one letter from Parker Pillsbury and another from Richard D. Webb. Also in the sub-series are two letters of introduction signed by William Lloyd Garrison. Fifield received an 1870 letter from Maria Weston Chapman upon the death of his mother, Hannah Cranch Fifield, and including a verse that might be her gravestone epitaph.

Also included with correspondence are letters relating to Tufts Library and the Fifield Collection, written by or addressed to Emily A. Porter Fifield (wife of William Cranch Bond Fifield) or her daughter Mary Fifield King.

Series II. Personal Papers and Ephemera. 1811-1926, n.d. These materials are arranged by person in generational order and then in chronological order. In addition to the Fifield family, some materials relate to members of the Porter family. Note that materials legal size and larger are found in a legal sized document box, a larger flat drop-front box, and beige flat clamshell box.

Of especial note in the Noah Fifield papers are the minutes of the Society for the Reformation of Morals, 1811-1818 and Fifield's address to the Society, both the manuscript and printed pamphlet, in 1818. Also present is the constitution, in Fifield's hand, of the Society for the Promotion of Temperance, c. 1832. An 1841 poster for the Weymouth and Braintree Temperance Celebration is in this sub-series. There also is a draft inscription for an album when Maria Weston Chapman went to England for her education in 1825. The town's resident poet F.M. Adlington penned *Lines to the Memory of Dr. Noah Fifield 1867 Oct 23* and a print copy mounted on board concludes this sub-series.

The Hannah C.B. Fifield subseries includes Weston sketchbooks sent from Europe, and some information about the Fifields' relationship with an African-American couple William and Charlotte Green Coleman. See Series IV Artifacts for Coleman items given to the Fifields. A poster for a *Public Meeting on The Fugitive Slave Law* held on Friday, November 7, 1851 in Weymouth is here although there is no evidence that she was involved or the owner of the poster.

The Mary Sanborn Fifield subseries includes a watercolor by Lucia Weston. Of interest in terms of personal history are diary entries and a travel diary kept by her as a young woman just before her death.

William C. B. Fifield subseries contains more anti-slavery materials when he was in Europe.

There are letters of introduction sent by William Lloyd Garrison on his behalf to English abolitionists, and a tour of London with George Thompson written by Thompson. Photographic images of Theodore and Lydia Cabot Parker that appear to be commercially produced also are found in this subseries.

Emily A. Porter/Porter Family subseries has disparate materials from pew purchase to school essays and mementos of the National Peace Jubilee concerts of July 1869 in which Susan B. Porter was a soloist. For the last, there are two programs, images of conductor Julius Eichberg and violinist Camilla Urso. A baton the conductor gave Porter can be found in Series IV Artifacts.

Mary Fifield King/Fifield Collection subseries has some information about the Fifield Collection and King's other historical efforts. Placed here are five large posters kept in the Library's flat file cabinet, four of which stamped Fifield Collection. They include two posters for Weymouth Anti-Slavery Fairs, years not stated, one for an Abington Anti-Slavery Fair in 1860, and two posters for Weymouth Universalist Fairs in 1854 and 1856. All were conserved by NEDCC in 2015.

Series III. Photographs. 1864-1910, n.d. This series is by format, and then chronological. All Fifield family members are represented in the photographs, as well as the parents and siblings of Emily A. Porter Fifield. Except for two photographs from the twentieth century they are studio portraits or photographic images of paintings or etchings.

There are glass plate negatives in a flip top box that may date from 1908 when someone had some of the family's case photographs (daguerreotypes) copied. The 1908 date is based upon the Kodak box in which some of them were housed. The glass plates should not be used.

The case and print photographs are in a single 5x7 photo box that also contains the images from two other collections (WCT010 Fogg and WCT002 Tufts). There are a total of twenty four different images. Of the more notable family members the number of images are limited: Noah, one; Hannah C.B., one; William C.B., two; Mary Sanborn, one. There also is a tintype of the Rev. Jonas Perkins and a print on board of a 1779 painting of Dr. Amos Holbrook who was a friend of both Cotton Tufts and Noah Fifield. Several of the daguerreotypes and other photographs were conserved by NEDCC in 2016. Photographs of the images have been taken and printouts of the images placed in the folders so that users can first view the image and decide if it makes sense to remove the original from its enclosure.

Three framed prints are stored separately: Joseph Palmer who had married a sister of Hannah C.B. Fifield; William Cranch (1769-1855) whose relationship with Hannah Cranch Bond Fifield has not been determined; and Noah Fifield, perhaps a plain salted print that is the same image as the daguerreotype of him. Also found here are two copies of a collage of photographic prints affixed to glass created for the 175th anniversary of the Old South Church, Weymouth in 1898. Images depict the ministers, church buildings, and parsonage

of the Old South Church, Weymouth. The one that seemed part of the Fifield Collection is broken; a second intact one may have been transferred to Tufts Library by the Braintree Library in 2011.

Series IV. Artifacts. 1830-1898, n.d. The container list describes each item. The list is by name of owner, when known, and date. The artifacts themselves are stored in the most appropriate enclosure for the particular item; one must carefully note the location of each when retrieving and returning. Many of the items have been placed in artifact trays measuring 10×15 and with 4, 6, or 15 compartments. The trays fit in a records storage box. Color images are included for many of the wrapped items.

There are several mourning lockets and rings, often inscribed with the initials and date of the deceased. The owner of much of the other jewelry is not known.

Some items of note are:

The Holy Bible ... printed for Berriman and Co. by Jacob R. Berriman, 1796. This folio size bible has been annotated with the "Family Record" of births, marriages, and deaths; the initial entries are by Hannah C.B. Fifield. There also are unidentified plant specimens between a few pages.

Herbaria purchased by Hannah C. B Fifield, 1834, 1830s, 1847. The earliest one has an annotation noting it was purchased at the first Boston Anti-Slavery Fair in 1834. Other herbaria, also originating from Scotland and England, may have been similar purchases.

Wallet, spoon, highway tax receipt, c. 1840s, belonging to William and Charlotte Green Coleman. Freed slaves, the Colemans were befriended by the Fifields.

Mary Sanborn Fifield's portfolio of sketches, c. 1840. Of particular interest is a pencil drawing of Mary Sanborn Fifield (head).

Mourning locket for Mary Sanborn Fifield, 1845, containing a portrait miniature and hair.

Metal powder flask, c. 1840, belonging to William C. B Fifield with note by Mary Fifield King.

William C.B. and Emily A. Porter Fifield wedding mementos, including gloves and sample of dress worn by the mother of the bride, embroidery work for the bride's wedding "outfit" and a small booklet likely presented to the couple by the Rev. Jonas Perkins and including a marriage certificate page completed and signed by Perkins on May 13, 1856.

Tufts Library Visitors' Log Book, 1895 - 1927, much of which devoted to the Fifield Collection. Included are news clippings about the Collection as well as the 300th anniversary of the founding of Weymouth.

Framed pencil drawing of house and property inscribed on reverse as Fifield Homestead, 1848.

Oval albumen print mounted on board of Frederick Douglass, c. 1885
