**Scope and Contents**: The Pamphlet Collection contains pamphlets owned by various individuals and collected by Mary Fifield King or donated directly to the Library. Among the owners of more than one pamphlet are: Cotton Tufts, Dr. Noah Fifield, Hannah Cranch Bond Fifield, William Cranch Bond Fifield, and Richard Cranch.

The collection is arranged in chronological order except for the last box. The container list provides the title, author, date, publisher and place of publication, as well as the owner's name, if known, and in comments the number of pages and inscriptions in the pamphlets.

In the last box of the collection there are two groups of pamphlets and one bound volume of pamphlets: 1) four pamphlets in a heavy board enclosure fastened with a purple ribbon and donated for the Fifield Collection by Mrs. Elliot C. Pierce, mostly likely in the early 1910s. They duplicate ones found elsewhere in the collection; 2) six children's literature pamphlets that were on display as part of the Library building's 50th anniversary and had come from the Fifield cabinets in the study room; and 3) a bound volume created by Noah Fifield and including some pamphlets originally owned by Richard Cranch.

Of particular interest in the collection are the political and anti-slavery pamphlets. The Fifields' involvement in temperance, women's rights, and anti-slavery efforts is well-represented; and the Boston Female Anti-slavery Society and Massachusetts Anti-slavery Society efforts are present.

There also are numerous sermons by ministers, some of whom are likely to have spoken of the political issues of the day. There are many Fourth of July orations and others for the dedication of Civil War monuments which also are of a political nature. Abolitionists held Fourth of July events before mid-century. Funeral orations are with some frequency for notables in the anti-slavery effort.

Authors who appear more than once include: Rev. Jacob Norton, Rev. Joseph Bent, Jr., Rev. Jonas Perkins, the Grimke sisters, Sarah and Angelina, Edmund Quincy, and Rev. Theodore Parker. Some but not all of the anti-slavery tracts published in 1855 by the American Anti-Slavery Society also are present in the collection.

There are several American Revolution and early national period pamphlets which may have belonged to Cotton Tufts, Abigail Adams' uncle who managed John and Abigail Adams' local affairs when they were abroad or in Philadelphia or Washington, D.C.

The Richard Cranch pamphlets found in the bound volume include ones authored by and given him by his nephew John Quincy Adams. Also in that volume are orations at the time of George Washington's death. The titles of authors of all pamphlets in the volume are noted in the container list.

A few pamphlets relate to local government in the late nineteenth century: a Water Department investigation and an effort to have the State purchase the Boston-Albany Railroad.

Some of the pamphlets may be rare. The archivist has not found *via* online searching another repository having the original Edes and Gill 1752 printing *God's Voice Crying to the Inhabitants of Weymouth...* It is in extremely poor condition and cannot be handled until it is conserved; the collection, however, contains the 1811 printing of the pamphlet which can and should be used instead.

Conditions governing access: Open for researchers but some are too fragile to use at present.
