MEETING MINUTES

The Meeting Came to Order At 6:00pm.

Mrs. Nardone led in the Pledge of Allegiance. See members present and absent above.

The Chair advised that the return to school plan will be presented tonight and reviewed to then be voted on at Thursday's meeting so that the plan can be submitted to DESE on August 10. If community members wish to speak at public comment (after School Committee members) they are asked to put name and address in the chat and will be called upon in order. Comments must be kept to 3 minutes and should be restricted to items on the agenda. Comments and questions may also be submitted by email.

The next school committee meeting is on August 20. There are ongoing discussions with the WEA (Weymouth Educators Association) and the chair thanked them for their participation and collaboration and encouraged WEA members to get involved.

New Business

The Superintendent echoed the Chair and thanked the WEA for their collaboration as well as the multiple bargaining units and highlighted that safety and health are of the utmost importance. Silent members are now part of the bargaining process, which allows members who are not on negotiating teams to observe the process.

a. Review School Year Calendar 2020-2021

Dr. Curtis-Whipple gave an overview of the changes. This latest version reflects a return to school plan and discussions with WEA. Professional Development around safety and learning practices for staff will take place on September 1-4, 8-11, and 14-15. The number of days for students has been reduced to 170 from 180. Staff working days will be 184. The first day of school will be on September 16, 2020. Open houses and conferences will be virtual. Superintendent Curtis-Whipple gave an overview of other professional development days. The last day of school will be on June 18, 2020.

Mrs. Curran clarified May 11 will be a ½ day of professional development.

b. Review Return to School Plan

Superintendent Curtis-Whipple gave an overview of the proposed return to school plan (which is the result of much collaboration and surveys). She shared her feelings that this is not a perfect plan, and can't make everyone happy. It was reiterated that this is a fluid document and could change even after submission as safety and health is of utmost concern and that dates are not definitive. The Superintendent expressed her hope that the state will provide metrics.

Dr. Curtis-Whipple acknowledged all the working groups and volunteers who helped to put this proposal together. An outline of the timeline, working groups and opportunities for feedback was given. The Superintendent encouraged community members to email 2020reopen@weymouthps.org with questions and comments. Communications were streamlined to one communication each Sunday. Data was used to make revisions to remote learning, which will be different than the spring. Instructional models and practices, equity concerns and communication were the focus.

The Superintendent thanked Interim Health Leader, Elaine Lane, Weymouth Department of Public Health, and Dan McCormack. Balance of risk was discussed. It was mentioned that the detection of child abuse is difficult to do when students are away from the building as well as difficulty delivering proper nutrition and other essential services.

A summary of the proposed plan which included the DESE mandated 3 models was given. Remote Learning for students K-12 will begin September 16. Hybrid phases will start no earlier than September 21 and JECC students (as their programs vary greatly) may be the only school to be 100% in person. An overview of the hybrid phases by grade level and cohorts was given. Families will have the choice to opt out and remain remote-a survey will be sent out on Sunday. The Superintendent brought attention to CTE students and high special need groups.

As buses will only be able to hold 24 students which may impact offering transportation beyond the mandatory threshold. Bus monitors will also be needed to facilitate COVID safety compliance.

Buildings have been taking safety precautions such as having clearly identified signs regarding health and safety, entry and exit, mask break areas, face mask instruction, and handwashing. The administration has been working closely with DPH and Elaine Lane. Buildings are required to have designated COVID sick areas. DESE health and safety requirements have been met. Staff and students will receive 1 washable mask. DESE has recommended 3 month supply of PPE (Personal Protective Equipment) and Weymouth has a 6 month supply.

Every effort is being made to have more than 3' of distance between desks in learning spaces. John Barker and Myra Jones are visiting buildings and assessing. Students in a lunchroom (if used) will be 6' apart facing forward. CDC recommends eating in classrooms to eliminate mixing cohorts..

Dr. Curtis-Whipple reminded that this is a fluid document based on the changing health landscape and reiterated her thanks and appreciation for all of the hard work by multiple stakeholders who have contributed to the return to school plan.

A copy of the presentation is attached to these minutes.

Chair Belmarsh thanked the Superintendent for the comprehensive plan and the pace of the plan. The FAQ's are available online and that public comment questions will be taken under advisement.

Dr. Sherlock-Shangraw advised that the meeting is being live streamed through her facebook account for community members that weren't able to log in to the zoom meeting. She clarified that families will have the choice to be fully remote and The Superintendent advised that a survey will go out on Sunday. Parent meeting/conferences at the beginning of the year will be used for parents/guardians to share information about how remote learning went in the spring and during the summer and how the students are doing during pandemic.

Dr. Sherlock-Shangraw expressed her thanks to the Superintendent and her team for the long hours of work and also shared her disappointment with DESE's lack of support of guidance and research based suggestions of how to reopen schools. Dr. Sherlock-Shangraw supports remote learning and hopes that data points, local health, and medical experts advise what should be used to move from phase to phase. She also shared her thoughts on offering remote, socially distant clubs and activities and reaching out to Town Council to partner to support families.

The Chair thanked Dr. Sherlock-Shangraw, Dr. Sullivan and Ms. Palazzo for their work and time in negotiation meetings over the last weeks.

Ms. Palazzo inquired if families choose remote if they'll be able to participate in athletics or extra curricular activities. The Superintendent advised that if a student is choosing to attend remotely then extracurricular participation would be forfeited. Cohorts and siblings, and class size was clarified.

Mrs. Curran thanked The Superintendent and her team for the proposal and Ms. Pitts for the hard copy of the presentation. She expressed her hope for data to drive decisions and inquired if there are numbers with daycares open of student and/or staff cases and agrees with balancing the risks. The Superintendent advised that it's difficult to get data with HIPPA. She also inquired if families are choosing to do private schools or online learning. The Superintendent advised that this data could be gathered at the building level. Clarification was made for staffing in regards to the Sunday survey. Mrs. Curran shared her desire to have on site COVID testing in a timely manner, and emphasized that students and staff will have to self certify.

Dr. Sullivan noted that there is good global data from American Association of Pediatricians, CDC and others. The plan aligned with best practices. He shared his appreciation.

Mrs. Nardone thanked the Superintendent and her team and inquired if all or some students would be returning to JECC. The Superintendent clarified that all students would be returning as there are varied programs and that the Sunday Survey is for families to opt out of hybrid learning and to remain remote for the first term, which is different by grade level.

The Chair shared that in these unprecedented times she has received emails and feedback in support of remote learning and in support of hybrid and that there is no right answer and to be respectful of all feelings. She feels that in addition to the COVID19 pandemic there is a pandemic of racial inequity and that she sees our black, indigenous, and people of color in our community. There is a racial equity sub committee, who also contributed to the return to school plan and expressed her hopes that they will still meet.

Ms. Belmarsh shared her feelings on not returning to any in person school unless safety can be provided to staff and students. She commended the definitive plans of safety developed; PPE, masks, distancing, cleaning, reducing students in building, however worries dates recommended are too soon. Suggested that metrics be considered.

Public Comment

-Laura Sabadini-382 Front Street

Chair Belmarsh read Ms. Sabidini's letter into the record regarding concerns with going back to school. She wants it to be safe for the whole community and to find better ways to support remote learning.

-Christina Pessia-29 Sea Captains Way

1. How are answers formulated for FAQ?
2. What is the protocol if someone in the family gets sick-not necessarily with COVID?

The Superintendent responded that similar questions are clustered and answers are included on the Sunday correspondence. Some questions that are more individualized will have individual reach out. Dr. Curtis-Whipple also stated that if someone in the home has tested positive for COVID that all members of the family should also stay home and that more information from health leader Elaine Lane would be needed.

-Mike Murphy, President WEA, 425 Front Street

Mr. Murphy read his comments into the record regarding the delay of hybrid learning until January 4, 2020 when more data and metrics have been received and it's safe to return. Mr. Murphy commented on local, national and world statistics.

Superintendent Curtis-Whipple wanted to ensure the community that the information regarding the football camp did not come from WPS.

-Rachel Collins, 23 Bengel Road

As a 1st grade teacher and mom of 2 kids shared that she doesn't believe it's safe to return to school at this time and to look at science and data before making a decision. She also shared her concerns for mask wearing for students aged PreSchool through grade 1 and that the social emotional learning will not be the same as before.

-Bill McCarty, Mt. Vernon Road West

Expressed his thanks to all the working groups and for the hard work in formulating a return to school plan.

1. Inquired how families will be notified if a student in the cohort tests positive for COVID and measures that will be taken after.
2. Inquired if there is a threshold for remote learning.

The Superintendent advised that at this time look to the state for metrics and would follow HIPPA guidelines and work with DPH

-Gina Walton, 12 Belmont St

As a 3rd grade teacher and mom of twin first graders expressed that small group work is impossible with returning to school in a hybrid format and advised that PreSchool-1st grade are asked to wear masks but not required and shared her concerns with Phase 2 and space accommodating students. She also stated that air circulation is poor and inquired if scheduled maintenance would be posted.

Superintendent Curtis-Whipple advised that a variety of spaces would be used to accommodate the splitting of cohorts to accommodate guidelines.

-Lisa Wiklund, 81 Aster Circle, Library ESP at Murphy,

Expressed her concern for student and staff health, wellbeing and safety as well as for the community and further stated because of the fluidity of the situation that it is unsafe to return to school without a vaccine in place.

-Kristie Bell, 1051 Commercial St

Expressed her concern in returning to school and that interaction and socializing would not be the same as before. She supports remote learning and expressed her feelings that it's unsafe to return at this time.

-Erin Dodds, 421 Summer St

She and her husband are full time essential workers and feel the greatest defense in COVID is PPE and wearing a mask and encouraged the school committee to have a universal mask order. Remote learning was not successful in their home over the previous spring and support a return to school listening to science and health care professionals.

-Patrick Shaefer, 64 Roberts Dr.

1. Inquired if students and/or staff will undergo regular COVID testing as so many could be Asymptomatic.
2. Suggested the parent councils be contacted in support of purchasing PPE or air purifiers
3. Inquired if families would notified if 1 of the students in the cohort is not wearing a mask? Would their own child have the option to move out of that cohort?
4. Inquired if all outdoor space would be used (weather depending) not just for lunches but outside instruction

The Superintendent agreed with leveraging outdoor space and parent councils pooling resources and suggested 6' beach towels (premeasured space)

-Cassi Belmarsh

Thanked all the staff and working groups for the return to work plan and emphasized that safety comes first and doesn't want to put her family at risk with returning to school. She pointed out the amount of time it would take away from the day to wash hands and also the length of class lines. Ms. Belmarsh also expressed her concern with phase 2 and class size and maybe having a class size cap.

The Superintendent expressed her appreciation for all staff speaking up and sharing and emphasized that all space is being leveraged and the possibility of extra staff hired.

-Jill Berry, Babcock Ave

As a Special Education teacher and mom of 3 expressed her support in delaying in person learning as it's unsafe at this time. The JECC students have the least developed skills and it conditions should be safe and inquired who would be implementing the oversight of building protocols and pointed out that staff will need to regown after each student when toileting.

-Catalina Fuerte, 291 Union Street

Shared that her family did contract COVID despite taking proper measures and supports kids going back to school and expressed her appreciation for the return to school plan.

-Joan Kilban, 12 Clinton Road

1. How long will families have to answer the Sunday Survey? Can they change their answer?
2. How will the delivery of instruction be handled for remote? Hybrid (watching from a camera at the back of a class, live, taped, interactive)?
3. Is it possible to give a better indication of the continuity of instruction.

-Caitlin McGinnes, 20 Neck St

Shared her concern for the Special education students and the neediest populations.

1. Encourages SC to put in place mask wearing, especially for younger populations
2. Where does Weycare stand?
3. When will families know cohorts?
4. Transportation-might be issue for some incoming Kindergarten students (it was for her-she's all set for her sons registered in June)
5. Requests additional staff hired be teachers not Paras
6. How can remote learning be rigorous and mirror in person learning (slide 14)?

Dr. Curtis-Whipple shared Ms. McGinnes' advocacy for the neediest populations and for mask wearing order. There aren't definitive plans for Weycare yet. Will try to keep in line with the 3rd Friday in August for notification of teachers however currently working with the WEA. Ideally would like to hire teachers, however posed budgetary concern. Mr. Wargo and curriculum will be following up with more information on Thursday about #6. Assistant Superintendent Smith advised that Robin Howard is working with First Student in complying with safety and workforce.

-Emily Sassola, 6 Brook Terrace

1. How will the delivery of instruction be handled for remote? Hybrid (watching from a camera at the back of a class, live, taped, interactive)?
2. What are the plans for substitutes to account for increased teacher absences.

-Liz Jaramillo, 245 Central St

1. What will the process be if a student or staff tests positive for COVID? Will cohorts be notified? How will information be disseminated?
2. What will remote learning look like? Watching from a camera at the back of a class, live, taped, interactive?
3. Supports mask order
4. If child stays home Term 1 and decide to be hybrid for term 2-what will that look like
5. Voting in November will there be extensive cleaning that night before students/staff return to the building the next day?

Inquired about payrider and not hearing if a child is confirmed for the bus.

Assistant Superintendent Smith advised still assessing and that Ms. Howard will be in contact and the district is legally responsible to provide transportation for K-6 outside of 2 miles.

Shared her agreement for Mike Murphy's statement and that it is not safe to return to school at this time and learning should be remote until the new year.

-Alicia Lyons, 90 Taft Rd

Expressed her thanks to the return to school working groups.

1. How long will families have to answer Sunday Survey? Can answer be changed?
Suggested adding more pick up locations for food if still remote this fall.

-Emily Henderson, 160 Sea St.

As a rising junior has the following questions:

1. Will students have more than 4 minutes to travel between classes?
2. Will the bus schedule be altered to accommodate only 24 kids on a bus?
3. How will cohorts at the high school be handled with different levels of courses (CP, honors, AP) and how will courses be affected?
4. How will schedules for students be matched?

-Annmarie Shaugnessy, 244 Congress Street

Advised that her student is in special education and has a 1:1 para and did not participate in remote learning last spring and supports in person learning.

-Joan Cederholm, Clapp Ave, VP of WEA

Expressed her concern in returning to school before the new year advising that the Social Emotional Learning part will not be able to be given in the same way (as much as the staff would like to) and is concerned with the model for opening schools.

1. What will class caps look like?
2. What will staff be like?

1. Why Monday cleaning? Why not Wednesday?
2. Will educators also be allowed to work remotely for PD days? What about Hybrid?

1. Will the state be appointing curriculum teachers for remote learning?

2. How will the survey be going out? Will it be sent to each email listed for a student?
3. Suggest High School zoom for senior student and families will info regarding college from guidance department
4. Inquired if attending term 1 remotely will student be allowed to attend extracurricular or athletics?

Shared her advocacy for families of medically complex or fragile students and feels that an informed decision can not be made at this time regarding in person learning. Ms.

Stukenborg also expressed hopes that if a medically disabled student attended remotely that they would be afforded the opportunity of extracurricular activities.

Superintendent Curtis-Whipple thanked Ms. Stukenborg for her advocacy and emphasized that due to a medical condition a student would not be excluded from participating in an extracurricular.

Inquired as to why the return plan changed to disinclude second grade.

Dr. Curtis-Whipple advised that it was for space reasons.

-Katherine Monteiro, 8 Chauncey Street

Inquired if DESE provided feedback on the back to school plan and expressed her concerns on safety in returning.

Assistant Superintendent Smith advised that DESE provided feedback to districts that were struggling with a return to school plan.

Chair Belmarsh advised that more formal information will be provided on Thursday.

-Katie Owens, WHS teacher

Shared her concerns for returning to school and supports delaying until the new year. She expressed concerns regarding custodial/maintenance staff safety. Ms. Owens stated that schools are more than just the buildings and that the teachers can figure out a way to meet the SEL needs of students remotely.

Chair Belmarsh expressed her thanks to the custodian/maintenance staff for all that they are doing related to COVID as well as packing up Chapman.

-Beth Aster, 159 Green St

1. If attending remotely will students still be able to attend prom?
2. Is it one way or the other for the Sunday Survey? Does majority win?

The Superintendent stated that it's individual family choice and the survey is to help with staffing.

Emphasized using all space (in and out) to ensure that kids remain 6' apart.

-Heika Tupland, 12 Emeline

Expressed her concerns with safety and returning to in person learning emphasizing the difficulty for students to follow guidelines. Proper ventilation is a concern. Ms. Tupland does not believe that teachers should be equated with frontline staff and the in person learning should be delayed until the new year.

-Cheryl Taylor, Special Education teacher at Hamilton

Expressed her support in returning January 4 for in person learning and advised that remote teaching will not look like it did in the spring and emphasized that in person Social Emotional Learning will not be the same.

-Ann Pike, 22 Colonial Rd

Shared her belief that live remote learning is the safest option and agrees with Mr. Murphy for returning on January 4th. Ms. Pike also expressed her disappointment in the Mayor's absence.

-Greg Agnew, 15 Lynn Way

Expressed that remote learning worked well for 1 of his children however not the other and supports remote learning until there is a safe vaccine. He shared his thoughts that teachers should have all available resources to make remote learning successful (pays taxes).

-Helen Murphy, 12 Rumindini

As a teacher expressed her concern for classroom size and pointed out that she has hexagonal tables and inquired how that would work with guidelines. Ms. Murphy emphasized that small group, explicit teaching is impossible at this time with returning to in person learning.

-Patrice Stutzenberger,

Shared her feelings that it's impossible to meet guidelines at the preschool level.

-Alicia Baker, 42 Seabury St.

Shared her feelings that to keep children safe, learning should be remote.

-Laurie Delano-56 Thomas Rd

Expressed here feelings that there are too many things to be determined with metrics and guidelines now and that staff shouldn't be required to be in the building if the students aren't

in the building. She supports remote learning and will email the school committee her other questions.

-Nicole Bradley, 15 Jacquelyn Rd

Expressed her thanks to the school working groups and also her concerns with class size and asked for more information.

-Jess Bradway, 120 Pierce Rd

Shared her thanks for the reopening plan. Ms Bradway expressed her feelings that its unsafe to return to in person learning at this time and shared her childcare concerns with the proposed schedule. She supports returning to in person learning in January.

-Robin Duff, 1250 Commercial St

Shared her thanks to the return to school working groups and expressed her concerns with returning to in person learning at this time and suggests remote learning until safety can be guaranteed.

-Emily Jackson DelRosa, 20 Ashmont St.

Supports delaying in person learning until January and stated that COVID should be taken seriously.

-Michele Denehy, 1st grade teacher at Pingree

Expressed her thanks to the Superintendent and team for the re-entry plan and suggested re-considering entry for the PD sessions for back to school. Ms. Denehy reiterated that the return to school affects the whole Weymouth community and urges the delay of in person learning until there is a safe vaccine.

Advised that wearing a mask protects other people from yourself in regard to being a carrier and being asymptomatic. She further stated that COVID is life and death and the timeline should be reconsidered.

Asked for the Superintendent to guarantee safety of staff, students and families with the return to in person learning.
