WEYMOUTH ASSESSORS MEETING OCTOBER 5, 2011

CHAIRMAN, PAUL HALEY, CALLED THE MEETING TO ORDER AT 7:00 P.M. AT THE MCCULLOCH BUILDING. THE FOLLOWING MEMBERS WERE PRESENT: PAUL HALEY, CHAIRMAN; KEVIN SPELLMAN, VICE CHAIRMAN; ROBERT BRINKMANN, AND JOHN SHEEHAN, ALTERNATE.

CHAIRMAN HALEY AND THE BOARD WELCOMED ROBERT BRINKMANN AS A NEW MEMBER.

A MOTION WAS MADE BY MR. SPELLMAN, SECONDED BY MR. SHEEHAN AND SO VOTED "TO APPROVE THE MINUTES OF SEPTEMBER 19, 2011 AS WRITTEN." ROBERT BRINKMANN ABSTAINED AS HE WAS NOT A MEMBER OF THE BOARD AT THAT TIME.

REORGANIZATION OF THE BOARD OF ASSESSORS TOOK PLACE AS FOLLOWS:

A MOTION WAS MADE BY MR. BRINKMANN, SECONDED BY MR. SPELLMAN, AND SO VOTED UNANIMOUSLY "TO APPOINT PAUL HALEY AS CHAIRMAN."

A MOTION WAS MADE BY MR. HALEY, SECONDED BY MR. BRINKMANN, AND SO VOTED UNANIMOUSLY "TO APPOINT KEVIN SPELLMAN AS VICE CHAIRMAN."

A MOTION WAS MADE BY MR. HALEY, SECONDED BY MR. SPELLMAN AND SO VOTED UNANIMOUSLY "TO APPOINT ROBERT BRINKMANN AS CLERK."

MRS. PANTERMOLLER INFORMED THE BOARD THAT THE ESTIMATED NEW GROWTH IS \$647,101.00. SHE SAID SHE JUST RECEIVED THE INFORMATION LATE THIS AFTERNOON SO SHE WILL HAVE THE BREAKDOWN AND BIGGEST CONTRIBUTORS AT THE NEXT MEETING. SHE REPORTED THAT THE UTILITIES WERE A MAJOR PART OF THE NEW GROWTH AND THAT SHE HAS FORWARDED THE INFORMATION TO THE MAYOR AND THE C.F.O.

MRS. PANTERMOLLER STATED THAT SHE HAS SPOKEN TO MR. MCKINNEY, C.F.O. REGARDING THE CLASSIFICATION HEARING, BUT HE HAS NOT HAD A CHANCE TO TALK TO COUNCIL PRESIDENT MATHEWS ABOUT IT YET.

SHE SAID SHE WILL E-MAIL THE BOARD ALL OF THE NECESSARY INFORMATION AND SHIFT OPTIONS SO THEY CAN VOTE ON THE SHIFT AT THE NEXT MEETING.

MRS. PANTERMOLLER INFORMED THE BOARD THAT OVERALL RESIDENTIAL PROPERTIES ARE PROPOSED TO HAVE A 1% DROP IN VALUE, BUT AS ALWAYS, SOME INCREASED AND OTHERS DECREASED BY VARYING AMOUNTS.
