

Minutes of the Board of Licensing Commissioners for their meeting held on Tuesday, February 24, 2015, at the Weymouth Town Hall, Chambers, 75 Middle Street

Chairperson Deree called the meeting to order at 1:30 PM.

APPLICATION OF **MJ RESTAURANT GROUP LLC D/B/A THE MOORING BAR & GRILL** FOR A CHANGE OF MANAGER ON THEIR ALCOHOLIC RESTAURANT/COMMON VICTUALLER LICENSES AT 117 BRIDGE ST. (CONTINUED FROM 12/16/14)

Mr. Michael Lally, Officer of MJ Restaurant Group, LLC and Mr. John McEachern, proposed manager were present.

Mr. Richards read the department referrals from Police Department reporting no objection.

Mr. McEachern introduced himself and stated he had been in the business for 26 years.

Mr. Lally stated Mr. McEachern stated he had been the kitchen manager and has assumed the role as General Manager.

Mr. Richards made a MOTION to approve the change of manager to Mr. John McEachern. Chief Stark seconded and the motion was UNANIMOUSLY VOTED.

Mr. Richards read the departmental referrals into the record. Officer Chase reported no public safety objection by the Police Department. Mr. McCormack reported the establishment was in good standing with the Health Department and had no objections to the change of officers/directors.

Mr. Richards reminded the applicant of the annual requirement to supply a report of officers/directors and current salaries to the Town and ABCC.
