

Minutes of the Board of Licensing Commissioners for their meeting held on Tuesday, May 23, 2023, at the Weymouth Town Hall, Chambers located at 75 Middle Street, Weymouth, MA

## **APPROVALS**

- Minutes: April 18, 2023

Mr. Richards made a MOTION to approve the minutes of April 18, 2023. Chief Stark seconded the motion and it was UNANIMOUSLY VOTED.

- Carnival Permit: “4<sup>th</sup> of July Celebration” (7/3/2023)
- One-Day Vendor Licenses: “4<sup>th</sup> of Celebration” (7/3)
