The intend is for the vehicles to remain in the Highway Transitional Zone. As recommended by the Planning Director, renovation or repair to the front sign, landscape repair to the Washington Street side of the building, fence against the property line on Washington Street to the rear lot line should be repaired or replaced as an enclosure.
