

Minutes of the Board of Licensing Commissioners for their meeting held on Tuesday, June 18, 2013, at the Weymouth Town Hall, Chambers, 75 Middle Street

Attendance (present): Chairperson Kathleen A. Deree; Jeffrey E. Chairperson Deree called the meeting to order at 2 PM.

APPROVALS

- Minutes: May 28, 2013

Mr. Richards made a MOTION to approve the minutes of May 28, 2013. Chief Grimes seconded and the motion was UNANIMOUSLY VOTED.

- One-Day Liquor Permit: Weymouth Lodge of Elks, 1197 Washington St.

Mr. Richards made a MOTION to approve the application for the One-Day Liquor Permit for the Mullin Bike Run to be held at the Weymouth Lodge of Elks on July 13, 2013 from 10 AM – 6 PM. Chief Grimes seconded and the motion was UNANIMOUSLY VOTED.

- One-Day Wine & Malt Permit: Margaritas, 765 Bridge St.

Mr. Richards asked Officer King if he had any comment.

Officer King replied he had no objections; it will be the same type of operation as they used for Cinco de Mayo.

Mr. Richards made a MOTION to approve the application for a One-Day Wine & Malt Permit for Margaritas event to be held in their outdoor patio during the 4th of July Celebration on Wednesday, July 3, 2013 from 4 PM – 11 PM. Chief Grimes seconded and the motion was UNANIMOUSLY VOTED.
