At a public hearing on 12/7/2022 the Board of Zoning Appeals;

**VOTED UNANIMOUSLY TO GRANT A SPECIAL PERMIT** under *Weymouth Zoning Ordinance Sections 120-40 (Extension or Change by Special Permit)* to add a two-story addition above the existing house. Approval is per a survey prepared by C.S. Kelley Land Surveyors. and dated 10/31/2022 and plan set titled *Renovations at 26 Colonial Road* prepared by Fisher Associates and dated 10/27/2022.

#### **SPECIAL PERMIT FINDINGS:**

The Board found that the proposal met the requirements for a Special Permit under Section 120-122 (D) as follows:

- 1. The specific site is an appropriate location for such a use. This lot is in an R-1 residential district. The addition is in keeping with the character and scale of the neighborhood. The Special Permit is required only because the lot is less than 5,000 square feet. None of the other pre-existing nonconformities are being extended or changed.
- 2. The proposed use or structure will not be detrimental or adversely affect the character or future character of the neighborhood or town. *The existing building is in disrepair and a*

- blight to the neighborhood. The addition is very much in keeping with the scale and character of the surrounding neighborhood.
- 3. There is not a potential for nuisance or serious hazard to vehicles or pedestrians. *The availability of off-street parking will not be impacted.*
- 4. There are adequate and appropriate facilities, utilities and other public services provided for the proper operation of the proposed use. All work will be done in conformance with Town of Weymouth Building Code and under the supervision of the Department of Public Works.
- 5. That the public convenience and welfare will be substantially served with the proposal. *The existing house is relatively small. The addition will provide needed additional living space and will dramatically improve the appearance of the property and neighborhood.*

#### **CONDITIONS:**

- Exterior material will be hardy plank or similar approved material on the front of the building.
- Master suite will have its own hip roof and the balcony will not have a roof/overhang as depicted on submitted architectural set.

Under MGL Chapter 40A, Section 11, the approval of the Board of Zoning Appeals will NOT take effect until it has been recorded in the Norfolk Registry of Deeds.

After the twenty (20) day appeal period has passed, the Town Clerk will send to the petitioner: (1) the certificate that no appeal was filed, (2) the certificate of granting of variance and/or special permit. The petitioner shall record these documents with the Norfolk Registry of Deeds, Dedham, MA, with the appropriate filing fee.

When a receipt from the Registry of Deeds is presented to the Building Inspector (to show that the decision has been recorded), the proper permit will be issued.
