At a public hearing on 2/24/2021 the Board of Zoning Appeals;

VOTED UNANIMOUSLY TO GRANT A SPECIAL PERMIT under *Weymouth Zoning Ordinance Section 120-40 - extension or change of a nonconforming lot. (Lot less than 5,000 sf)*

The decision of the Board is based on a survey entitled Plan Showing Proposed Addition in Weymouth, MA, dated 12/23/2020 and stamped by Joseph L. Calabro. Also presented are architectural elevations of the addition prepared by Mr. WENG, Ruifeng (Contractor)

FINDINGS:

The Board found that the proposal met the requirements for a Special Permit under Section 120-122 (D) as follows:

1. The specific site is an appropriate location for such a use. *This is an addition to an existing single-family home. The addition is at the rear of the building and creates no new nonconformities.*
2. The proposed use or structure will not be detrimental or adversely affect the character or future character of the neighborhood or town. *The proposed addition is in keeping with the existing character of the neighborhood with regards to size and scale*

3. There is not a potential for nuisance or serious hazard to vehicles or pedestrians. *The project will not impact the availability of off-street parking. Currently at least two spaces exist.*
4. There are adequate and appropriate facilities, utilities and other public services provided for the proper operation of the proposed use. *The addition will be constructed in accordance with all Town of Weymouth Building Codes and all DPW sewer requirements.*
5. That the public convenience and welfare will be substantially served with the proposal. *The addition will allow the applicant to stay in his existing home and will increase the property value of the home.*

CONDITIONS:

None


Under MGL Chapter 40A, Section 11, the approval of the Board of Zoning Appeals will NOT take effect until it has been recorded in the Norfolk Registry of Deeds.

After the twenty (20) day appeal period has passed, the Town Clerk will send to the petitioner: (1) the certificate that no appeal was filed, (2) the certificate of granting of variance and/or special permit. The petitioner shall record these documents with the Norfolk Registry of Deeds, Dedham, MA, with the appropriate filing fee.

When a receipt from the Registry of Deeds is presented to the Building Inspector (to show that the decision has been recorded), the proper permit will be issued.

IMPORTANT: Notice is further given that any person aggrieved by this decision may appeal, according to MGL Chapter 40A, Section 17, and said appeal, if any, must be filed with the Town Clerk within twenty (20) days after the filing of the decision with the Town Clerk.




Certificate of Granting of Variance or Special Permit

The Board of Appeals of the Town of Weymouth hereby certifies that a Variance or Special Permit has been granted to Qiang (Jon) Lu, 26 Weybosset St., Weymouth, MA 02191, affecting the rights of the owner with respect to land or buildings at 26 Weybosset St also shown on the Weymouth Town Atlas Sheet 6, Block 56, Lots 4, and the said Board of Appeals further certifies that the decision attached hereto is a true and correct copy of its decision granting said variance – special permit, and that copies of said decision, have been filed with the Planning Board and the Town Clerk.

The Board of Appeals also calls to the attention of the owner or applicant that General Laws, Chapter 40A, Section 11 (last paragraph) provides that no variance or special permit, or any extension, modification or renewal thereof, shall take effect until a copy of the decision bearing the certification of the Town Clerk that twenty days have elapsed after the decision has been filed in the office of the Town Clerk and no appeal has been filed or that, if such appeal has been filed, that it has been dismissed or denied, is recorded in the registry of deeds for the county and district in which the land is located and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title. The fee for such recording or registering shall be paid by the owner or applicant.
