Chairman DiFazio called the meeting to order at 6:47 PM.

## 13 088-Reserve Fund Transfer-Police Department Overtime

Chief Grimes and Capt. Comperchio were invited to the table. The request is for \$45,000; \$25,000 for the anticipated election and \$20,000 to support services provided to Boston during Marathon events. This is a precautionary move; they will be deep into end of fiscal year when this payroll comes out. It was noted that there may be state reimbursement for the marathon impact. Chairman DiFazio asked if there are funds elsewhere in the police budget to cover this. Capt. Comperchio responded that the FY13 CBA impact must be absorbed in the budget. Auditor Swanson reported that he analyzed the data provided and MUNIS and there appears to be adequate funds remaining. Between the overtime required for the Boston bombing incident and the election, it appears there will be adequate funding. Chief Grimes noted that there was one election in April: the second in June will overexpend the account.

A MOTION was made by Vice Chairman O'Connor to forward measure 13 088-Reserve Fund Transfer-Police Department Overtime to the full Town Council with a recommendation for favorable action and was seconded by Councilor Molisse. Councilor Mathews asked the Chief to work with the auditor moving forward; a biweekly report and reconciliation was suggested. CFO McKinney again noted this is a precautionary measure. UNANIMOUSLY VOTED.

## 13 089-Sewer Department-MWRA I/I Phase 7 Allocation

Director Bina and Water Superintendent Tower were invited to the table to review the request for \$944,000 for Phase 7 work. The funds will be used to investigate and plan for future I/I work. This request is an authorization to borrow the funds. The actual projects will involve removal of infiltration from the system. This measure is strictly a request for authorization to bond and not to perform the actual work, and is a 45% interest free loan from the federal government rather than the use of funding from retained earnings .

This is the first step working with MWRA- once they meet the criteria, MWRA loans the funds, but they are required to bond the entire \$944,000. Auditor Swanson asked if there is back up to support this measure. David Tower responded that they have an award letter from the MWRA. Phase 8 is already on the table. Weymouth has been awarded \$7 million thus far and there is \$5.23m sitting at MWRA to date. It was noted that there are I/I projects going out to bid later in the month. The town has not done a major I/I project in several years. Councilor Mathews noted he is a proponent of I/I and he wanted to be sure that

before they request funds, that they are compliant. David Tower responded the actual costs incurred to complete the project are less than \$5M and that all policies put in place in the consent order are still in play today. Auditor Swanson asked if the language in the measure was redundant; Mr. Tower responded that the language is what was recommended by the Bond Council to be included in the measure.

A MOTION was made by Vice Chairman O'Connor to forward measure 13 089-Sewer Department-MWRA I/I Phase 7 Allocation to the full Town Council with a recommendation for favorable action and was seconded by Councilor Molisse. UNANIMOUSLY VOTED.
