3. 550-560 Washington Street - Notice of Intent, Public Hearing - Previously Continued

Map 29, Block 330, Lot 3

Demolish existing building and construct a 3-story mixed-use building.

Mr. Jennings was in attendance. Most of the discussion and revisions were completed in the last two meetings and submitted to the Conservation Office. All comments have been addressed except for additional details on slope planting and maintenance. All DPW comments were addressed.

Mr. Hultin recommends the following series of conditions as follows:

- Stockpiling outside the 100ft buffer
- Dewatering process
- All debris be removed from the length of the slope and from within the wetland both on and off the property, including trash and landscape material
- Disturbed areas seeded with Conservation seed mix
- Riverfront mitigation work shall be conducted to the final approved mitigation plans and shall be overseen by a Wetlands Professional
- Split rail fence for delineation along the parking lot
- 2-year monitoring on mitigation area with 75% survival rate for vegetation
- Invasive species management plan for 2 years along the slope
- · COC requiring as built plan from an Engineer
- Remove all rubbish fill until reaching natural soils, then regrade

A Motion was made by Cmmr. Loring and seconded by Cmmr. Donovan to issue a Standard Order of Conditions (OOC), with all special conditions mentioned

 158 Park Ave West – Notice of Intent, Public Hearing, previously continued Michael Grehan
 DEP File #81-1308
 Map 44, Block 512, Lot 1
 Construct three multi-family homes and associated parking, utilities, and drainage.

Shawn Hardy, Hardy + Man Design Group, and Michael Grehan were in attendance.. Mr. Hultin explained that the applicant and representative have answered the majority of the concerns. The DEP File # was issued since the last meeting. Discussion around the the flood areas and the restrictions for the AUL ensued, but no concerns were raised. The remaining comments, namely the reconfiguration of the infiltration chambers and an updated restoration/mitigation plan, were not of major concern to the Commission and they felt these comments could be conditioned into the Order of Conditions.

Staff recommended issuing an Order of Conditions (OOC) with special conditions

A Motion was made by Cmmr. Loring and seconded by Cmmr. Donovan to close the public hearing.

Mr. Hultin continued with the special conditions:

- Silt sock with a wire back fence around the perimeter of the site for erosion control
- project will need to comply with all conditions established in the AUL (ex. utilizing a slab foundation for the building)
- Work within the AUL shall be overseen by a Licensed Site Professional
- Planting plan shall be revised prior to the start of construction, it shall increase and diversify the native plants in the Riverfront mitigation area
- Revision to show reconfiguration of infiltration chambers
- All plants subject to a 2-year monitoring period, any damaged or dead plants will need to be replaced. Monitoring should result in 75% survival of plants or greater
- COC will need an as built plan as well a letter from an engineer certifying to the Order of Conditions (OOC) in the approved plan.
- 2-year monitoring period shall show 75% survival rate of the plantings

A Motion was made by Cmmr. Donovan and seconded by Cmmr. Loring to issue an Order of Conditionswith special conditions mentioned

 1183 Main Street – Request for Certificate of Compliance Sonia Dahlquist DEP File #81-1275 Map 53, Block 554, Lot 19 Construction of a parking lot

Shawn Hardy, from Hardy + Man Design Group, presented on behalf of the applicant. Mr. Hardy explained that there were deviations from the final approved plan, namely the addition of a concrete slab, two retaining walls, and an increase in square footage of restoration/mitigation area. He suggested that the additional mitigation should compensate for the addition of the concrete slab, as the square footage is similar. Mr. Hultin explained that during the site visit, they found erosion control (silt sock) still in place and a small amount of construction debris was found in the forebays. Staff recommends approving the COC, but holding off on issuance until the applicant has provided evidence that the silt sock and construction debris have been removed from the site. Mr. Hultin also informed Shawn that commercial vehicles should not be stored on the pad as per zoning laws.

A Motion was made by Cmmr. Loring and seconded by Cmmr. Donovan to issue a Certificate of Compliance pending the erosion control removal.

19 Lambert Ave – Violation Hearing
 Drena & Wayne Nicholas

 Construction of a retaining wall without approval

Mr. & Mrs. Nicholas attended the meeting to discuss the violation with the Commission. Mr. Hultin updated the Commission that the Mayor's office contacted the Conservation Office after receiving calls about a new retaining wall being built on Whitman's Pond. . Staff conducted a site visit and found a new retaining wall roughly 3' into Whitman's Pond constructed of cinderblocks and crushed stone. The new retaining wall replaced a derelict retain that had largely been overtopped with dirt and vegetation. Mr. Hultin contacted the homeowners and suggested their attendance at this meeting.

The homeowner expressed their intentions and explained they viewed the area as a safety hazard. The Commission expressed concerns of hardening of the bank and the location of the retaining wall. The Commission also expressed concerns about parking vehicles on the wall, as the vehicles are likely adding pollutants to Whitman's Pond with their persistent presence.

Mr. Hultin recommended that the homeowners consult a wetland scientist or engineer to suggest corrective actions. This should result in the submission of a Notice of Intent for work recommended by a professional.

A Motion was made by Cmmr. Donovan and seconded by Cmmr. Loring to continue this item until the August 29th, 2023, meeting.

DER expects the engineering firm to revise SLRs plans first before starting the permitting process. Conducted electroshock surveys with MassWildlife and found many eels, pickerel, and other fishes, but no trout.
- Fore River Trail Woodard and Curran provided preliminary plans and scope of work.
 Staff is providing comments before the plans and scope are finalized and put out to bid.
- Brook Trout Research Project water samples shipped to UMaine to do eDNA testing for brook trout. No hits for Brook Trout DNA.
