#### **STAFF REPORT**

46 Union Street

members killed in the melee as documented by Weymouth historians Jack Frost and G. Stinson Lord in "Two Forts to Destiny." It is believed the actual site of the Weston Colony was on a glacial esker (per Ted Clarke, former chair of your commission) called Hunt's Hill at the far edge of King's Cove. The site was removed for a South Boston construction project. The par on Sea Street, built at the urging of the Weymouth Historical Society, seems to be serving as an unofficial sand-in representing the Weston settlement. The park is located immediately adjacent to the Indian burial ground. Remains were reburied in North Weymouth cemetery.

My personal preference is for a plaque located in the Sea Street park commemorating the burial ground for the Massachusetts natives who dies in the struggle with Myles Standish, while noting that the actual blockade site is now under water about one-quarter mile away.

I have written articles about the Weston Colony and the Massachusetts tribe for the Quincy Patriot-Ledger and my blog Inside Weymouth (insideweymouth.com).

Chet Kevitt served for many years as president of the Weymouth Historical Commission and as president of the Weymouth Historical Society. To honor his memory and encourage similar commitment, the Commission created an award to a person or persons who has made an outstanding contribution to the preservation of Weymouth's heritage or the understanding of its history. The recipient need not reside in Weymouth, and should not currently serve on the Commission. The names of the honorees shall be displayed in the Historical Room of the Tufts Library.

Mr. Mark Schneider asked who chooses the winner of the contest and does the commission want to let the public submit nominations?

Mr. Murphy wanted the nomination in writing, less than a 200 word essay.

Ms. Torrey said the decision of winner shall be the commissions.

Mr. Walker stated Chet Kevitt was the founding member of the Historical Commission and the Chairman.

Mr. Eric Schneider stated the awarding can be done at a town event.

Mr. Murphy asked the commission can the winner win more than once.

Ms. Torrey nominee must have contributed to a project, written a book, etc.

Mr. Murphy suggested making a list of past winners of Chet Kevitt Award on website.

Ms. Torrey stated she will make a MOTION to APPROVE the above referenced letter be sent to the mayor. Mr. Walker SECONDED the MOTION. It was UNANIMOUSLY VOTED.

Mr. Murphy asked if a marker is put up in the town, who puts it up? Chairman Clarke stated the Memorial Committee is in charge of markers being placed.

Mr. Eric Schneider stated there is a new motion going out for benches/trees/markers for memorials to the Memorial Committee.

The next meetings of the Historical Commission will be held on May 21, 2019. Mr. Schneider will check and see if the Fogg Library is available for this evening.
