RE: Notification of Scheduled Natural Gas Release

Algonquin Gas Transmission, LLC

Weymouth Compressor Station (Transmittal No. X266786)

Dear Mr. Cushing:

Algonquin Gas Transmission, LLC (Algonquin) was issued Air Quality Plan Approval - Transmittal No. X266786 (the Plan Approval) by the Massachusetts Department of Environmental Protection (MassDEP) on August 26, 2019. The Plan Approval authorizes the construction and operation of the Weymouth Compressor Station, 50 Bridge Street, Weymouth, Massachusetts.

The compressor station is currently under construction and is mechanically complete. The next step in the construction process is to begin commissioning activities, which include testing and calibrating piping and equipment to ensure proper operation. Starting the week of September 8th, natural gas will be introduced into the station for the first time. The recently installed pipeline, interconnects to the existing meter station and the newly constructed compressor station will be tested to ensure the facilities will operate in a safe manner, as designed. Between September 8th and September 12th, station piping and equipment will be tested for leaks and the Emergency Shutdown System (ESD) will also be tested.

As gas is introduced, the station piping must be purged of air. Purging involves using natural gas in an existing pressurized pipeline to remove air from the new pipeline and safely bring the new section of pipeline to a functioning state. Gas will be released during the purge process, and to also reduce system pressures for testing and any other necessary adjustments. This gas will be vented through a charcoal trailer brought on site in order to minimize odor associated with mercaptan, which is injected into natural gas for safety reasons.

Testing of the ESD system will also result in the release of natural gas. The gas vented during the ESD test will not be vented through the charcoal trailer because it must be vented through the ESD blowdown stack in order to test the system. This gas will have a mercaptan odor associated with it.

In accordance with Section 3.B., Table 11, Condition 2 of the Plan Approval for the Weymouth Compressor Station, Algonquin is required to notify MassDEP prior to any scheduled gas releases at the Weymouth Compressor Station that are expected to exceed 10,000 scf of natural gas. The estimated total volume of natural gas anticipated to be released during commissioning activities occurring between September 8th

and September 12th is 675,000 standard cubic feet (scf). Natural gas will be released during commissioning activities the week of September 8th as outlined in the table below.
