PUBLIC HEARINGS

19 114-Utility Petition- NGRID Pole Relocation- Madison Street, held December 2, 2019, continued to December 16, 2019 to January 21, 2020

A motion was made by Vice President Molisse to reopen the public hearing on measure 19 114 and was seconded by Councilor Smart. Abutters were notified on November 15, 2019. This was continued from December 2, 2019 and again until December 16, 2019. UNANIMOUSLY VOTED.

Simon Yeung, engineer at NGRID, presented the petition, to install a new pole on Madison Street.

President Mathews noted that the DPW has sent an email, since the last public hearing, stating that there is sufficient space for the pole relocation.

President Mathews asked if there were any questions or comments from the public, to which there was the following response:

Arthur Sharp of Regatta Road-noted that pole P1, located in front of Madison, is leaning into the street and he spoke with Jim Pierson (Simon's boss) who said they are hoping to replace that pole with a taller one. Additionally, NGRID would like to put outriggers facing one side of the pole into the street. The other side of the street (Ryder property) is 135 feet from the proposed pole location and Mr. Sharp suggests eliminating the P1 pole and do a straight run into Broad Street. He believes this would save money as well and he asked that Simon take this proposal back to NGRID.

President Mathews asked Mr. Sharp if he had an issue if the Town Council approved this petition or would he prefer that NGRID investigate his alternative. Mr. Sharp acknowledged that he understands that the project needs to go forward, but would like this option explored.

President Mathews confirmed that this was Simon's first time speaking with Mr. Sharp. He would like a conclusion this evening but if NGRID is willing to consider this alternative, he would be amenable to continuing the hearing.

Simon stated that NGRID was focused on the wishes of 668 and this suggestion would result in additional costs that he doesn't feel should be borne by them.

President Mathews noted that he is willing to continue the hearing but for the record-Mr. Sharp attended the initial public hearing and no one showed from NGRID; the second hearing Mr. Sharp's concerns were not addressed. If he continues this—this must be resolved.

Councilor Harrington inquired if this is an emergency situation and whether this action would need to be approved that evening. He also asked who the current owner of 668 Broad Street is. Simon responded that although this isn't an emergent situation, 668 is waiting on construction and it is unknown if the Town Council approved this and the suggestion is accepted by NGRID, if new paperwork would be required.

Councilor Haugh asked a procedural question regarding if NGRID was amendable to Mr. Sharp's proposal of removing P1, if they would have to come back before the Council to accomplish this or could they just remove it as part of the project-- if the Council voted to approve. She noted that Mr. Sharp stated he was content with the proposal NGRID gave him but would prefer the removal of the pole.

Councilor Smart asked Simon to put some effort into addressing the outstanding issues and be prepared for the next meeting.

A motion was made by Vice President Molisse to continue the public hearing on 19 114 to February 3, 2020, and was seconded by Councilor Smart. UNANIMOUSLY VOTED.

COMMUNICATIONS AND REPORTS FROM THE MAYOR, TOWN OFFICERS AND TOWN BOARDS

Joe Callanan presented measures on behalf of the Mayor's Office.

20 002- Reserve Fund Transfer for Copiers

That the Town of Weymouth transfer the sum of \$20,000 from the reserve fto the asset management equipment account for the purposes of funding costs associated with purchasing two (2) copiers, one each for the Town Clerk and DPW departments. The lease on these has expired. Purchasing copiers, including maintenance and supplies, is less expensive than leasing.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 003- Free Cash Transfer to the Stabilization Fund

That the Town of Weymouth transfer the sum of \$1,000,000 from free cash to the stabilization fund.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 004- Free Cash for Field and Park Improvements

That the Town of Weymouth transfer the sum of \$375,000 from free cash for the purpose of funding costs associated with the construction of a utility building (with restrooms and concession and storage space), and the installation and repair of batting cages at Libby Field, and all other costs incidental and related thereto.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 005- Free Cash for New Tufts Library Collection

That the Town of Weymouth transfer the sum of \$100,000 from free cash for the purpose of funding costs associated with the purchase of new materials for the new Tufts Library Opening Day Collection.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 006- Free Cash for New Tufts Library Playground

That the Town of Weymouth transfer the sum of \$410,656 from free cash for the purpose of funding costs associated with the construction of a new accessible playground at the site of the New Tufts Library, including equipment, installation and all other costs incidental and related thereto.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 007- Free Cash for Matching Funds for Columbian Square Grant

That the Town of Weymouth transfer the sum of \$50,000 from free cash for the purpose of funding the town's share of costs associated with the completion of a survey and preliminary engineering plans (25% design) for the revitalization and reconstruction of Columbian Square, and all other costs incidental and related thereto.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 008- Free Cash Transfer for Electric Vehicles

That the Town of Weymouth transfer the sum of \$48,000 from free cash for the purpose of funding costs associated with the town's share of leasing five electric vehicles through the Massachusetts Electric Vehicle Incentive Program (Mass EVIP).

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 009- Free Cash for Road and Sidewalk Improvements

That the Town of Weymouth transfer the sum of \$2,000,000 from free cash for the purpose of funding costs associated with road and sidewalk improvements.

President Mathews requested that backup documentation is supplied to the Council. Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 010-Borrowing Authorization for Road and Sidewalk Repairs and Reconstruction

Joe Callanan noted waiving of the reading of the measure, per Bond Counsel ruling, so long as entire measure is recorded in the minutes.

Ordered: That the Town of Weymouth appropriate the amount of Three Million Dollars (\$3,000,000) for the purpose of paying costs associated with repairing and reconstructing Town roads and sidewalks, and for the payment of all other costs incidental and related thereto, said sum to be expended under the direction of the Town of Weymouth Construction Steering Committee, and to meet said appropriation of the Town of Weymouth's Chief Financial Officer, with the approval of the Mayor, is authorized to borrow said sum under M.G.L. Chapter 44, or any other enabling authority.

Any premium received upon the sale of any bonds or notes approved by this order, less and such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this order in accordance with M.G.L. C.44, ss20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

This measure requires a legal notice, public hearing, and 2/3 vote of all members of the Council, as required by M.G.L. Chapter 44, Section 1.

Language subject to Bond Counsel review.

President Mathews requested that backup documentation is supplied to the Council.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 011- Borrowing for Cost Associated with Replacing the Ralph Talbot Primary School's Boiler System

Joe Callanan noted waiving of the reading of the measure, per Bond Counsel ruling, so long as entire measure is recorded in the minutes.

Ordered: that the Town appropriates the amount of One Million Dollars (\$1,000,000) for the purpose of paying costs of the complete removal and replacement of the Ralph Talbot Primary School's original boiler system located at 277 Ralph Talbot Street, South Weymouth Massachusetts 02190, which proposed repair project would materially extend the useful life of the school and preserve and asset that otherwise is capable of supporting the required educational program, said sum to be expended under the direction of the Town of Weymouth Steering Committee, and to meet said appropriation of the Town of Weymouth's Chief Financial Officer, with the approval of the Mayor is authorized to borrow said sum under M.G.L. Chapter 44, or any other enabling authority, and that the town of Weymouth acknowledges that the Massachusetts School Building Authority ("MSBA") grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any Project costs the Town of Weymouth incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town of Weymouth; provided that any grant that the Town of Weymouth may receive from the MSBA for the Project shall not exceed the lesser of (1) Fifty Six point Two Percent (56.26%) of eligible, approved Project costs, as determined by the MSBA; or (2) the total grant amount determined by the MSBA and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement that may be executed between the Town of Weymouth and the MSBA.

Any premium received upon the sale of any bonds or notes approved by this order, less and such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this order in accordance with M.G.L. C.44, ss20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

This measure requires a legal notice, public hearing, and 2/3 vote of all members of the Council, as required by M.G.L. Chapter 44, Section 1.

Vice President Molisse motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart. VOTED UNANIMOUSLY.

20 012-Reserve Fund Transfer-Funding of Measure 18 126
