Ordinance Committee – Councilor Gary MacDougall

23 125 - Proposed Change to Town of Weymouth Zoning Ordinance Extending Village Overlay District

Vice Chair MacDougall reported out and stated that this measure was received in the clerk's office on October 3, 2023. The Ordinance Committee initially met for this measure on November 1, 2023, and the public hearing was held on November 13, 2023. The Planning Board met and

held a public hearing on November 14, 2023, and sent their recommendation to the Ordinance Committee on November 16, 2023. The ordinance committee met again on November 27, 2023.

Chair MacDougall read two memos into the record. The first one is the actual measure proposed changes and the second is a letter/memo from the Planning Board. He then read the committee meeting notes that were compiled as of November 27, 2023. He added that the Ordinance Committee met a final time on November 27, 2023, and voted unanimous favorable action 5-0 to approve the zoning change of measure 23 125.

Chair MacDougall stated that he is recommending favorable action on 23 125. He reminded the Council that the zoning change requires a two-thirds vote. Councilor Molisse seconded the motion.

President Mathews stated that before he opens it up to the Council for discussion, that after the Ordinance Committee met and voted favorable action, he received a communication from the Mayor that was sent to all Councilors, requesting that it be read into the record. He then read the letter into the record.

Councilor MacDougall stated that the memo came in well after the public comment period was closed. He noted that it is unfortunate that they were not able to have this information for discussion before the Ordinance committee voted. He referenced Rule 26 which states that once the public hearing is closed, no further communication or public testimony can be accepted. He continued that the Mayor attended some of these meetings and had the opportunity to speak about his concerns. He continued that he still does not think that the concerns outweigh the value that this change is going to do. He stated that he supports this measure.

Councilor Burga asked for clarification that this property was originally part of the Village Center Overlay District (VCOD) and at that time, the town took the position that it would be okay to include this type of building in the VCOD. She questioned if it was the Council's recommendation to pull it out of the VCOD.

Councilor Mathews stated that the decision was made in collaboration with the Planning Department, the Planning Board, and the administration.

Councilor Burga continued that it seems like the Council has changed their position as well as the Mayor's Office and Planning Board. She added that she would like to respect the desires of and consideration for Councilors of their district.

Councilor Kiely stated that she lives on Vine Street, so this project definitely impacts her and her property values. She continued that she has heard and respects Mr. Luongo's concerns as well as the Mayor's opinions. She noted that this is just the beginning of the process and even if this is allowed, there are still steps to be taken. She stated that she respectfully disagrees with those that do not think it should move forward.

The motion to approve the zoning change passed unanimously 11-0. Roll call vote as follows:
