District Six Councilor Search Committee -Announce Committee Composition and Logistics -Chairman Michael Molisse

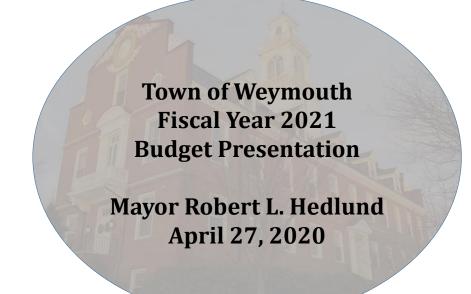
Vice President Molisse reported on the committee creation and the schedule. He read the process from the Charter. On March 6, the president announced the formation of a search committee, consisting 5 members. The candidates were solicited and responded by March 16th. Applications were reviewed for residency, voter status, and the first meeting was held last week to determine how to move forward. Twelve candidates responded and were contacted regarding interviews. The meetings will begin in open session but interviews will take place in executive session. Each candidate will be offered the chance to answer two questions from each of the committee members. Once the interviews are complete, the committee will make a recommendation to the full Town Council for its deliberation.

COMMUNICATIONS AND REPORTS FROM THE MAYOR, TOWN OFFICERS AND TOWN BOARDS

<u>Presentation of Fiscal Year 2021 Budget – Mayor Robert Hedlund – Ted Langill-</u> Chief of Staff

Mayor Hedlund addressed the Council, beginning by wishing the Council and the public well, and commending the Chief of Staff for the presentations, with a shout out to the staff; especially in the collections office. This is uncharted territory with the pandemic and the town is months away from knowing the full fiscal impact. They don't have the answers. This is the beginning of a longer process. The budget will change more than once in the upcoming year, and is dependent upon how much aid the town receives from the federal government. Assumptions are presented based on the most up to date information. A freeze was instituted on spending and not filling positions. Expenses are being kept down, and resources kept to diminished demand. As a result of the pandemic, they need to expect and prepare for significant declines in state revenues. They plan for the worst, but hope for the best. This was not the traditional budget exercise. They plan to keep what has been built. A salary freeze was instituted for all nonunion employees. Operating expenses were reduced. Fixed costs (health insurance, debt service, pensions, retirements, building and liability insurance) increases are a consideration and they are rising by about \$3.8 million (2.2% increase over 2020). To offset the rising costs, they had to reduce other department budgets and line items by \$177,573,130 (1.8% increase over 2020), Water Enterprise budget is flat, Sewer Enterprise is 1.5% over, CPA \$918,000. There are a couple of areas of hope; with sound fiscal management they were able to grow the reserves so there is \$8.2 million in stabilization. They are proposing to use most of the remaining free cash to create a Covid-19 reserve. They expect some federal relief, but with strings attached. Use of any of the one-time reserves will only temporarily fill expected revenue gaps. Measures will help only if the economy rebounds sooner than later. Circumstances will overtake any degree of planning they take here. He commended the department heads, staff and the council, and he gave a shout to essential employees, first responders, grocery workers, truck drivers and volunteers in town.

Chief of Staff Langill presented the following COVID-19 budget reflecting the current state and noted, as the Mayor indicated, this will not be the final one presented.

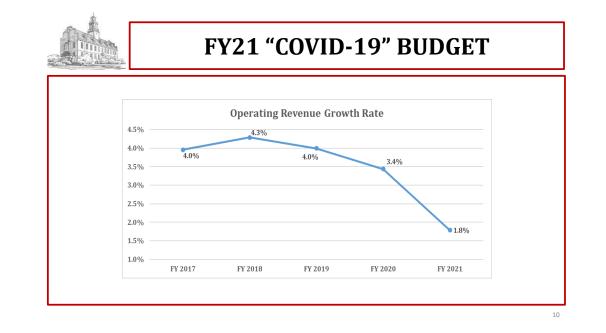

USE OF STABILIZATION FUND (and Reserves)

Stabilization Funds are meant for just that - to stabilize our existing finances, <u>not</u> to spend more.

The use of any one-time reserve, stabilization or bailout measures would only serve to <u>temporarily</u> fill revenue gaps in hopes of keeping our head above water in the short-term.

These measures would only help in the long-term *IF* the economy starts to rebound sooner than later (in FY21) *AND* our recurring revenues grow back to a point of being able to permanently fill the budget shortfalls.

Chief of Staff Langill summarized that the sooner the town can recover, the better off the town will be. He urged that people follow the guidelines, and flatten the curve to improve conditions sooner. He thanked the public health personnel, first responders, and essential workers doing their part.

Councilor Heffernan thanked the administration for the presentation. The town is in a much different place than six weeks ago. He noted how quickly the change happened, with a global economic reversal. It will be wide scale, and will be ever-changing event. It appears they are well prepared to deal with the economy in Weymouth and the budget.

Councilor Happel thanked the Mayor, Ted and staff. He liked the implementation of \$1000, and would like to know if that will save money going forward. Mr. Langill responded that he expects the revenue to be less next year, and expects free cash will be a much lower next year, but doesn't know what it means going forward. it's a \$4.8 million problem that will need to be fixed.

Councilor Hackett asked Mr. Langill to give an overview of the current projections for this round of the budget. Mr. Langill responded that most comes from the tax levy, state aid, local receipts, and lowered each of them. Revenue projections are estimated. The state has built up a stabilization but what remains to help cities and towns remains to be seen. The town has had pretty conservative budgets in the last few years, to their benefit now. New growth should be up there, but payments were delayed, and unemployment effect is unknown at this time. Going back to 2010; the town didn't have a decrease in tax revenue. Councilor Hackett asked if \$1.5 million in free cash rolling to a reserve fund is over and above the \$1.8 million? Mr. Langill confirmed that is was.

Vice President Molisse thanked them (a brief power outage interrupted his attendance). He appreciated the openness in the process, and looks forward to working it out.

Councilor Heffernan noted Massachusetts was declared a public health disaster zone; and asks if the administration expects any of the funds to be seen by Weymouth, and if so, how much or when? Mr. Langill responded that he is unsure as they are waiting to see. Councilor Heffernan responded that it seems to be focused in the 4th stimulus bill under consideration. The Disaster declaration included funding.

Councilor Haugh thanked the Mayor and CFO. She noted that school personnel also are present. Schools are always the biggest part of the budget, although they are getting the biggest chunk of the low increase it means they will be facing cuts as wells. She asked to confirm they will meet on Thursday to discuss the steps they will have to take. They confirmed.

- 1. Line Item Transfer from Town Solicitor –Judgment, Claims and Damages line item to Town Solicitor-Litigation-Special Counsel line item in the amount of \$40,000.
- 2. Line Item Transfer from Town Solicitor-Salaries line item to the Town Solicitor-Litigation-Special Counsel line item in the amount of \$89,072; and
- 3. Supplemental Appropriation from Free Cash to the Town Solicitor-Litigation Special Counsel line item in the amount of \$78,794.

This measure requires a legal notice and public hearing.

CFO Langill noted the measure actually refers to three transactions.
