## 21 080 Free Cash for Fire Department Dispatch / Record Systems

On behalf of Mayor Robert Hedlund, Municipal Finance Director James Malary requested that the Town of Weymouth transfer the sum of \$210,000 from Free Cash into an 02 fund account for the purpose of funding costs associated with the purchase of a new dispatch and records management system for the Weymouth Fire Department

#### 21 081- Reappointment to the Cultural Council-Dominic Paulo

21 082-Proposed Amendments to the Town's Tax Title Payment Agreements Ordinance

On behalf of Mayor Robert Hedlund, Municipal Finance Director James Malary requested that the Town of Weymouth, through Town Council and with the approval of the Mayor, hereby amends the Town of Weymouth Ordinances in the following manner:

**"Section 1**. Section 5-307a of the Town of Weymouth Code of Ordinances is hereby amended by striking out subsection (a) and inserting in place thereof the following subsection:-

- (a) In accordance with the provisions of G.L. c. 60, § 62A, the Treasurer may enter into payment agreements with the owner of an eligible property in tax title. The eligibility criteria and terms are as follows:
  - 1. Eligible categories. The category of eligible tax titles shall include any property taxes as either commercial or residential property;
  - 2. Payment agreement. The agreement shall be in writing, dated, and signed by the taxpayer and Treasurer, and shall include a schedule of payments;
  - 3. Initial payment. Taxpayers must pay at least twenty five percent (25%) of the total amount due at the inception of the Agreement;
  - 4. Interest waiver. The Treasurer, after receipt of the initial payment, and all terms of the Agreement have been complied with, may waive up to fifty percent (50%) of the interest accrued in the tax title account. No taxes or collection costs may be waived.
  - 5. Term of payment agreements. Payment agreements shall be offered for a maximum of five (5) years. All current taxes and fees owed to the Town must be current and accounts in good standing. Nonadherence to the terms of the plan will nullify the agreement and a new agreement cannot be started in the same fiscal year.

**Section 2**. Section 5-307a of the Town of Weymouth Code of Ordinances is hereby amended by striking out subsection (b) in its entirety.

This measure requires legal notice and a public hearing."

#### REPORTS OF COMMITTEES

### **Budget/Management Committee-Chair Michael Molisse**

Chair Molisse reported that the Budget/Management Committee met on May 3, 2021 to deliberate the following measure(s):

### 21 053- Independent Audit Fee

This measure was referred to the Budget/Management Committee on April 5, 2021. The committee met on May 3, 2021 and voted to forward the measure to the full Town Council with a recommendation for favorable action.

On behalf of the Budget/Management Committee, Vice President Molisse made a motion to approve measure 21 053; that Town of Weymouth transfer the sum of \$4,000 from the Reserve Fund to the Town Council Audit Fees for the purpose of funding an additional \$4,000 expense from the Independent Auditors (Melanson). Councilor Kiely seconded the motion.

Town Auditor Swanson informed the administration that Melanson was required to perform additional audit work for the Federal Single Audit FY20 that was not budgeted in FY21. Melanson's Engagement Letter for FY21 stipulates "Additional fees may apply if more than two federal programs must be audited." Three federal programs were required to be audited.

### 21 056- Council Authorization to Expend CDBG/HOME Funds FY21-22

This measure was referred to the Budget/Management Committee on April 20, 2021. The committee met on May 3, 2021 and voted to forward the measure to the full Town Council with a recommendation for favorable action.

On behalf of the Budget/Management Committee, Vice President Molisse made a motion to approve measure 21 056; that the Town of Weymouth accepts the Fiscal Year 2021-2022 HUD grants in the amounts of \$729,350 for CDBG and \$168,105.60 in HOME Investment Partnership Grant Funds; both are allocations from the US Department of Housing and Urban Development (HUD), as amended (to included revised backup).

Furthermore, that the Director of Planning and Community Development, having received the approval of the Mayor, be permitted to expend said grants in their entirety as described on the attached funding allocation lists.

Both are allocations from the US Department of Housing and Urban Development (HUD).

These amounts are estimated as HUD will not have actual award amounts until a later date, however, approval is needed prior to the date of notification of the actual grant. Councilor Kiely seconded the motion.

## 21 058- Reserve Fund Transfer – 53rd Payroll

This measure was referred to the Budget/Management Committee on April 20, 2021. The committee met on May 3, 2021 and voted to forward the measure to the full Town Council with a recommendation for favorable action.

On behalf of the Budget/Management Committee, Vice President Molisse made a motion to approve measure 21 058; that the Town of Weymouth transfer the sum of \$562,801 from the FY21 Reserve Fund to an 02 fund account for the purpose of funding the 53rd payroll in FY21, covering Sunday, Jun 27th through Saturday, July 3rd. Councilor Kiely seconded the motion.
