Chairman Flynn called the meeting and the public hearing order at 7:00PM.

WEYMOUTH HISTORIC COMMISSOIN PRESERVATION REQUEST - FIRST CHURCH, MEETING HOUSE ITEMS

Ms. O'Leary made a MOTION to APPROVE the REQUEST FOR FUNDING for items at First Church, Meeting House. Mr. Condon SECONDED the MOTION. Discussion.

Mr. Clarke stated he has concern with some of the items. Chairman Flynn suggested that the Committee take items one by one and discuss.

#1 Bible Case w/ argon gas

\$3,640

Could/would be used to swear in another mayor and for the wedding reenactment of John and Abigail Adams.

#2 & 3 Pulpit (top & base)

\$2,675 and \$1,782

Chairman Flynn stated that the quotes given were not estimates; costs for materials and supplies were shown. Ms. Nancy Cameron stated that the quote is for materials and the work to install.

This pulpit dates back to 1833; Chairman Flynn stated it is preservation and restoration of an historical item.

#4 Steeple Restoration \$34,285

\$19,000 has been paid to date to the contractor out of the \$34,285. Chairman Flynn stated the steeple in its restoration is being restored to its original style, shape and paint. Mr. Clarke offered a point of information; this is one of the first times funding work that has already been done is being requested.

#5 Reguilding of historic (period) weathervane \$2,350

Chairman Flynn asked how many churches has this weathervane been on. Mr. Cameron stated that weathervanes such as this were used at other sites were town meetings were held.

#6 Front Door Replacement Historic (period) Replication \$23,340 New doors will replicate what is there now; size, weight, with ADA compliance.

Chairman Flynn stated items 7 through 11 are in his opinion "maintenance" and CPC is not allowed to fund "maintenance".

#7 Conservation of wood trim of Pews \$2,970

Ms. Cameron stated that the wood trim is from 1833, this item is for conservation of the wood trim on pews only. Mr. Clarke stated he felt the Committee could allow this item. Mr. Condon stated he agrees with Mr. Clarke and Chairman Flynn on this item.

Chairman Flynn made a SUBSTITUTE MOTION to APPROVE THE APPLICATION IN PART, ITEMS 1-7 in the amount of \$71,042.00 from Historic Resources. Mr. Condon SECONDED the MOTION. It was UNANIMOUSLY VOTED.

Mr. Condon asked if CPC approved the application for the full amount and Town Council approved can CPC let application go as it stands. Chairman Flynn stated no.

Chairman Flynn stated that First Church can resubmit for funding to restore the ceiling paint if further damage results from steeple and weathervane damage.

Mr. Wilburn stated that the church has been gaining new younger members. Last year is the first year the church ran in the black. Mr. Wilburn is confident that the church will grow for years to come; church has been here since 1623.

Mr. Harrington asked is the CPC setting a precedent here regarding giving monies to a church. Chairman Flynn indicated that many grants of CPS funds have been provided to churches, particularly those with significant historical background. Mr. Flynn further commented that the request might have been better submitted as repairs to the Meeting House. Historically in Weymouth this building is known as The Meeting House.

SUBSTITUTE MOTION - VOTE; UNANIMOUSLY VOTED.

Ms. O'Leary made a MOTION to Close the Public Hearing. Mr. Condon SECONDED the MOTION. It was approved unanimously.
