WEYMOUTH LANDING DEVELOPMENT - PROJECT REVIEW

Steve Cecil. principal of the Cecil Group, was present to review the findings and recommendations of the report. He stated that he had been tasked to review the latest site plans for both the Weymouth and Braintree projects and evaluate parking demand, building design, and Smelt Run daylighting options.

Mr. Cecil prepared a composite plan showing both projects and lot layout. He noted that the Braintree project should have sufficient parking and the Weymouth project demand is currently above available supply. However, the town could work to increase parking by removing the pump station and reconfiguring the lot.

Mr. Cecil presented a board that showed four different locations for daylighting the Smelt Run. The locations were similar but varied enough to merit consideration, especially if Braintree is unable to acquire property to daylight their side of the brook.

Steve Cecil noted that the building designs were traditional and well scaled to the commercial neighborhood. He noted that the layout should take advantage of the walkway along the Smelt Brook.

Authority members and staff had some comments and questions. They were generally pleased with the report and thanked Steve Cecil for his work.
