COMPLETE STREETS

The original presentation was given on June 23, 2015. Mr. Schneider stated staff has put together a resolution that the town can adopt. This complete streets resolution includes handicap accessibility and healthy living suggestions; these goals guide decision makers to consistently think are we thinking about making this space easy to use for all people; accessibly for all.

The Complete Streets Policy will be enforced by the Planning Department but all departments will help to carry out the policy. Benefits will include; 50 million dollars that has been authorized and allocated for this policy.

Please review, this is a draft document; hoping for comments from the Planning Board. MAPC came and gave a presentation at the meeting on August 20, 2015.

Ms. Akoury asked how state guidelines tie into town with regards to Route 18 and Route 53. Mr. Clarke stated with Fore River Bridge the state Department of Transportation accommodated with bike lanes.

Chairman Williams asked how Planning Board would go about adopting the Complete Streets Program. Mr. Schneider stated there are a number of ways to adopt the program: It is based on a points system; language recommended. For example: Rockway (part of Mediterranean Woods) needed to put in a sidewalk.

Mr. Clarke stated Hamilton School was recently repaved; the lot, entrance and sidewalks. Mr. Clarke had the traffic engineer go look at all and make sure that all would be done properly.

Mr. Clarke suggested Planning Board adopt Complete Streets Policy and make part of rules and regulations. Chairman Williams agreed and suggested staff gives Planning Board members a chance to review document and discuss at the next meeting.
