## **APPROVALS**

- Minutes of October 27, 2015

Mr. Richards made a motion to approve the minutes of October 27, 2015 and was seconded by Keith Stark. VOTED UNANIMOUSLY

## **HEARINGS**

Application of Elmanahry Enterprises, Inc. D/B/A Gio's Roast Beef and Pizza for a Common Victualler license at 17 Middle Street, Weymouth, Ma

Mr. Richards stated a request was received and as the applicant was not present, he made a MOTION to continue this Public Hearing to December 29, 2015 and was seconded by Mr. Keith Stark. VOTED UNANIMOUSLY

Application of AJIT Enterprises, Inc. D/B/A Taj Modern Indian Cuisine for a Wine and Malt Restaurant License at 312 Bridge Street, Weymouth, Ma

Appearing before the board was Attorney Mark Zuroff and the applicant Balwinder Kaur. The applicant has a beer and wine license and the previous owner had one as well.

There was no public comment.

Mr. Dan McCormack asked if they will be performing TIPs training and 21 proof training and it was stated yes, both training will be done.

Mr. Richards made a MOTION to approve the Common Victualler license for Gio's Roast Beef and Pizza at 17 Middle Street, Weymouth and was seconded by Mr. Keith Stark. VOTED UNANIMOUSLY

Mr. Jeff Richards made a MOTION to approve the One Day All Alcohol License for the Weymouth Club for the 4 Tennis Socials stated and was seconded by Mr. Keith Stark.

- Red Rose - Mr. Richards stated that this is to change the hours of operation for one day on November 26, 2015 to serve alcohol with breakfast to begin at 8:00 am.

Mr. Jeff Richards made a MOTION to approve the One Day Change of Operation Hours to begin at 8:00 am at the Red Rose and was seconded by Mr. Keith Stark.  
VOTED UNANIMOUSLY

Chief Grimes stated that this is something the Red Rose does every year.
