

Minutes of the Board of Licensing Commissioners for their meeting held on Tuesday, July 25, 2017, at the Weymouth Town Hall, Chambers, 75 Middle Street

Chairperson Deree called the meeting to order at 2 PM.

APPLICATION OF OLYMPIC PIZZA, INC. FOR AN INCREASE OF SEATING ON THE COMMON VICTUALLER LICENSE AT 15 UNION ST.

Mr. Richards stated the hearing was continued from the last meeting.

Mrs. Frannie Xerokostas stated they are expanding to the right of them and will be adding more Greek food. The Municipal Lot behind them was newly paved.

Mr. Richards stated everyone has a copy of the plan; abutters were notified and newspaper advertisement was publicized.

Mr. McCormack stated they would require a Health inspection prior to opening.

Mr. Richards announced the public hearing for comment.

Mr. Richards made a MOTION to approve an increase of seating on the Common Victualler license of Olympic Pizza, Inc. Chief Stark seconded the motion and it was UNANIMOUSLY VOTED.

Attorney Cavanagh represented The Alumni 836 LLC, stating there are no additional new members; Mr. Alexandros Kesaris has left the LLC.

Mr. Thomas came forward, stating he is two doors away. A change of hours of operation was approved; lately they seem to attract motorcyclists. They have been revving their motorcycles and it is not appreciated by the neighbors. If the establishment doesn't speak with their customers, he will be recommending a police detail.

Mr. Richards made a MOTION to approve the change of beneficial interest on the All Alcoholic Restaurant license of The Alumni 836, LLC at 836 Washington Street. Chief Stark seconded the

motion and it was UNANIMOUSLY VOTED.
