

Minutes of the Board of Licensing Commissioners for their meeting held on Tuesday, June 24, 2014, at the Weymouth Town Hall, Chambers, 75 Middle Street

Attendance (present): Chairperson Kathleen A. Deree; Jeffrey E. Richards, Director of Municipal Licenses & Inspections; Daniel McCormack, Director of Public Health; Fire Chief Keith Stark; and George E. Lane, Jr., Town Solicitor

Chairperson Deree called the meeting to order at 1:30 PM.

APPLICATION OF PATRICK B. MCGRATH D/B/A GABRIELLA'S FOR A COMMON VICTUALLER LICENSE AT 1690 MAIN STREET

Mr. Patrick B. McGrath was present for the hearing. He stated that he plans on running the business the same way and there will be no change.
