A MOTION WAS MADE BY CHAIRMAN HALEY AND SECONDED BY MR. SPELLMAN TO GO INTO EXECUTIVE SESSION.

THE VOTE BEING UNANIMOUS, CHAIRMAN HALEY STATED THAT WE WILL NOW ENTER EXECUTIVE SESSION FOR THE PURPOSE OF REVIEWING ABATEMENT APPLICATIONS, AFTER WHICH WE WILL RETURN TO OPEN MEETING.

THE BOARD DISCUSSED AND REVIEWED QUEEN ANNE V FOR FISCAL 2015. A MOTION WAS MADE BY CHAIRMAN HALEY AND SECONDED BY MR. SPELLMAN "TO ACCEPT THE OFFER FOR QUEEN ANNE V BRINGING THE VALUE TO \$4,053,600. FOR FY 2015 ONLY."

MRS. O'TOOLE INFORMED THE BOARD THAT GASLIGHT VILLAGE WITHDREW THEIR ABATEMENT REQUEST FOR FY 16. DISCUSSION TOOK PLACE REGARDING THE FY 15 VALUE.

THE BOARD REVIEWED SEVERAL ABATEMENT APPLICATIONS. DECISIONS WERE MADE ON EACH ONE AND SO NOTED ON THE APPLICATION.
