MRS. PANTERMOLLER INFORMED THE BOARD THAT RICHARD SWANSON HAD COMPLETED THE INTERNAL AUDIT OF THE ASSESSORS OFFICE.

THE MINUTES OF THE MEETING OF JULY 16, 2014 WERE UNANIMOUSLY APPROVED AS WRITTEN.

THE MINUTES OF THE MEETING OF NOVEMBER 12, 2014 WERE UNANIMOUSLY APPROVED AS WRITTEN.

THE MINUTES OF THE MEETING OF DECEMBER 1, 2014 WERE UNANIMOUSLY APPROVED AS WRITTEN.

A MOTION WAS MADE BY MR. SPELLMAN AND SECONDED BY MR. BRINKMANN TO GO INTO EXECUTIVE SESSION.

THE VOTE BEING UNANIMOUS, CHAIRMAN HALEY STATED THAT WE WILL NOW ENTER EXECUTIVE SESSION FOR THE PURPOSE OF REVIEWING ABATEMENT APPLICATIONS AND CONDUCTING HEARINGS, AFTER WHICH WE WILL RETURN TO OPEN MEETING.

MR. AND MRS. HYSKO, 287 MIDDLE ST., WERE PRESENT TO DISCUSS THE VALUE OF THEIR PROPERTY. THEY SAID THAT ON THE WEBSITE IT SAYS 5 BEDROOMS AND THEY ONLY HAVE 2.

CHAIRMAN HALEY EXPLAINED THAT THE BEDROOM COUNT IS FOR INFORMATIONAL PURPOSES AND THAT THE ASSESSMENT IS BASED ON THE SQUARE FOOTAGE. HE SAID WE WILL CHANGE THE BEDROOM COUNT, BUT IT WON'T CHANGE THE ASSESSMENT.

MR. BRINKMANN EXPLAINED THAT PREVIOUS TO PK BEING ABLE TO INSPECT THE HOME, OUR RECORDS INDICATED THAT THE UPSTAIRS WAS NOT FINISHED. HE EXPLAINED THAT HE UNDERSTANDS IT WAS FINISHED WHEN MR. AND MRS. HYSKO BOUGHT THE HOME, BUT IT WAS NEVER PICKED UP IN OUR RECORDS, PERHAPS BECAUSE THERE WAS NO BUILDING PERMIT OR WE WERE NEVER ABLE TO GET INTO THE HOME. AFTER INSPECTION, THE CORRECTIONS WERE MADE, SO THE VALUE INCREASED.

MRS. HYSKO SAID SHE HAS AN APPRAISAL DONE BY THE BANK AND WILL SEND IT TO US.
