MRS. PANTERMOLLER ALSO INFORMED THE BOARD THAT SHE HAS RECEIVED SOME INFORMATION FROM ATTORNEY WULSIN ON 110 MAIN ST. AND HAS FORWARDED IT TO PAUL KAPINOS.

A MOTION WAS MADE BY CHAIRMAN HALEY, SECONDED BY MR. BRINKMANN, AND SO VOTED UNANIMOUSLY "TO ISSUE A TEMPORARY ABATEMENT FOR 1471 MAIN ST BRINGING THE VALUE TO \$349,000 FOR FY 15 ONLY DUE TO THE  $2^{\rm ND}$  FLOOR VACANCY."

A MOTION WAS MADE BY MR. BRINKMANN, SECONDED BY CHAIRMAN HALEY, AND SO VOTED UNANIMOUSLY "TO ISSUE AN ABATEMENT FOR 120 SANDTRAP CIRCLE BRINGING THE VALUE TO \$775,000 FOR FY15 ONLY."

A MOTION WAS MADE BY MR. BRINKMANN, AND SECONDED BY MR. SPELLMAN TO COME OUT OF EXECUTIVE SESSION.

THE BOARD APPOINTED BRENDA O'TOOLE ASSISTANT ASSESSOR FOR FY 2016.

MRS. PANTERMOLLER INFORMED THE BOARD THAT SHE WOULD BE RETIRING ON JULY 31, 2015.

THE BOARD THANKED MRS. PANTERMOLLER FOR HER 22 YEARS OF "A JOB WELL DONE" AND SAID THAT EVERYONE WILL MISS HER.
