The Law

The Community Preservation Act found at Massachusetts General Law chapter 44B, as amended and as voted upon by the Citizens of the Town of Weymouth in November, 2005, permits the Town to raise monies through a 1 percent surcharge on the real estate tax levy on real property. The Town has adopted two exemptions based upon residential use and value.

Mission Statement

The Committee will recommend the expenditure of these funds to acquire, create and preserve open space; acquire and preserve historic resources; create, preserve and support community housing; and acquire and/or preserve land for recreational use.

Chairman Flynn has asked the Finance Office for updated revenue numbers. Mr. Bois has been unable to complete this task as yet.

Mr. Ford asked if any decision has been made on the interior plans for the Fogg Library. Mr. Clarke stated that he spoke with Mayor Kay today. Mayor Kay would like to have all the plans together by the spring, sit with the new Director of the library, and discuss.

Mr. Clarke stated this project is completed except for the new signs and the water that is going to be brought to the site. This additional work is being done for free. Mayor Kay wants to have an event at the site in the spring.

Mr. Clarke stated that the funds for this project are on hold because the Town is trying to assess the appropriate way to take care of the weeds in the pond without damaging the plants and fish in the pond. A study is being done.

Mr. Clarke stated that this project requires a special meeting of the CPC with Gene Raymond to discuss combining Phases 2 and 3 into one (1) phase. A special meeting is to be held on February 17, 2011.

Chairman Flynn stated that a new group has been formed. The group is meeting to discuss fundraising for Legion Field. Their first meeting is tonight in the Kelly Room.

Mr. Clarke stated that John DeVito from Northern Contracting volunteered his time and equipment to demolish and remove the home that was located on the parcel/land acquisition at Neck Street.
