## 06 121-Sale of Town Owned Land (discussion necessitates Executive Session)

Mr. Wilson stated that an auction has been scheduled. The purpose of this measure is to establish a minimum price for each parcel. The amounts are included in the second page of the measure.

He noted that there are two changes; on the Main Street property the minimum bid of \$700,000 is reduced \$600,000. The auctioneer believed that in order to obtain the fair market value of \$700,000, it would be more advantageous to list it at \$600,000.

President Smart asked what the zoning of this property is. Councilor Mathews stated that the lot is zoned Highway Transition (HT) to the front of the property and R-1 to the rear.

The second change is that the address is Randall Avenue not Randall Street

The motion is to set the minimum bid at \$1,040,000.
