Chairman DiFazio called the Budget/Management Committee Meeting to order at 6:30pm.

FISCAL YEAR 2006 BUDGET MEASURES

Richard Swanson spoke of revenue concerns regarding the whether the Town will receive State aid of \$500,000 and the fact that the 53rd week is not included in the budget.

James Wilson stated that the Mayor sees the current budget as a work in progress. He handed out a spreadsheet showing projected figures. He noted that if the balance of Free Cash, which is \$806,540, is expended for the snow removal deficit, the deficit will be reduced to \$41,644.24.

Mr. Wilson then detailed the items on the spreadsheet and noted that the 53rd week will be prefunded. He also noted that he included a number of items in the budget such as the funding for the traffic supervisors contract which was signed today, as well as a copier for the treasurer's office, the fire alarm lease, and vehicle maintenance for DPW.

FY 05 is projected to end with a surplus of \$195,596.40. However, in going over the numbers for FY 06, he projected a potential deficit of \$595,099.94. With FY 06 Free Cash projected at \$500,596.40, from the surplus from FY 05 and \$305,000 in Bond Premium, a deficit is expected in FY 06 of approximately \$95,000.

Mr. Wilson stated that there are currently nine (9) union contracts still to be negotiated.

Councilor McPherson asked when the Town would have a permanent bond on the high school project. Mr. Wilson stated that this would happen after the audit in September.

After some discussion, it was decided that a brief overview of the budget would be given at the full Town Council meeting.

Councilor Kay asked if the Administration could give the Budget/Management Committee a weekly update. Ms. Hackett stated that she is in touch with Councilor DiFazio, and President Lacey when changes occur.

It was noted that a 53rd week occurs every six (6) years. However, Mr. Wilson stated that the Department of Revenue does not allow the setting aside of funds for this.
