A MOTION was made by Councilor Kay to REAPPOINT Donald Sheehan to the Weymouth Housing Authority and to bring the recommendation to the full Council and was seconded by Councilor Molisse and UNANIMOUSLY VOTED.

Councilor Kay informed members that Robert Galewski was out of town this evening and was unable to be present.

A MOTION was made by Councilor Kay to REAPPOINT Robert Galewski to the Zoning Board of Appeals and to bring the recommendation to the full Council and was seconded by Councilor Molisse.

Councilor Leary stated that he would not be voting in favor of any members requesting reappointment to the Zoning Board of Appeals who voted in favor of the Lexan project at Arbor Hill - this included Robert Galewski, Alternate Member.

05 081-Reserve Fund Transfer-\$1,300-Parking Tickets

At this point Jim Wilson/Chief Financial Officer came before the Council. He informed members that the funding was needed for parking ticket administration, adding that in his 10 years dealing with parking tickets this is the first time he has seen a Reserve Fund Transfer request for this line item. He explained it was necessary due to the high number of traffic tickets that were issued due to the unusually snowy winter. He said there already was a shortfall for the third quarter and he would need additional monies to administer the parking ticket program for the fourth quarter. Specifically \$1,100 is needed for anticipated expenses and \$139 for outstanding monies due.

Councilor Kay wanted to point out that although this budget is up, additional revenues from tickets generated because of various offenses; such as, 'overnight parking' and 'parking in handicapped spaces' would offset this expense.

A MOTION was made by Councilor Leary to recommend FAVORABLE ACTION on Item #05 081, Reserve Fund Transfer in the amount of \$1,300 for Parking Tickets and was seconded by Councilor Molisse and UNANIMOUSLY VOTED.

05 077-Sale of Town Owned Property

Next Jim Wilson/Chief Financial Officer requested the Chairman take Item #05 079/Appropriation Request - \$10,000 – Sale of Town-Owned Property out of order, as the two remaining items would be addressed in Executive Session.

A MOTION was made by Councilor Molisse to take Item #05 079 out of order and was seconded by Councilor Kay and UNANIMOUSLY VOTED.

05 079-Appropriation Request-\$10,000-Sale of Town Owned Property

Mr. Wilson explained that \$10,000 was needed from 4903 to cover the expenses involved with the Sale of Town-Owned land, plus a Reserve Fund Transfer of \$320. He said these funds would be expended to pay for a number of expenses that would include such items as the cost of the auctioneer, the recording of deeds, advertising, etc. He explained that the sale would be conducted under the auspices of the Tax Title Committee. The membership of this committee includes Jim

Clarke and Paul Halkiotis of the Planning Department, the Town Solicitor, Inspector of Buildings, the Treasurer and himself.

A MOTION was made by Councilor Kay for FAVORABLE ACTION on Item #05 079 in the amount of \$10,300 with \$10,000 to come from #4903 and \$320 from a Reserve Fund Transfer and was seconded by Councilor Molisse and UNANIMOUSLY VOTED.

At 6:50 PM a MOTION was made by Councilor Leary that the Budget/Management Committee go into Executive Session for the purpose of considering the value of real property involved in the upcoming public auction of Town Owned Property, since such discussion may have a detrimental effect on the negotiating position of the Town Council relating thereto, and to reconvene in Open Session for the purpose of Adjournment. This motion was seconded by Councilor Molisse and was UNANIMOUSLY VOTED. Roll call vote was conducted as follows:
