Council President Mathews called the meeting to order at 7:30 P.M. Franklin Fryer conducted a roll call with all Councilors present.

Announcement of Committee Designations-Council President Mathews

Announcements

Councilor Molisse warned constituents of a mailing from "State of Massachusetts, Norfolk County" which claims that constituents are responsible for maintenance and repair of their water line, and requests payment to insure their pipes.

He confirmed with Robert O'Connor that this mailing was not initiated by the town and cautions constituents as to its integrity.

Secondly, he announced that the Council office has received in excess of 56 emails on the proposed renovations to Riley Field. To date the Council has not received a plan from either administration nor the Weymouth Sports Council, but once they do it will be shared with the community.

Councilor Harrington noted his support with the Mayor's initiative to curb drug use in the town, he noted that his comments, as recently published in the Weymouth News, may have been taken out of context. He supports Mayor Kay's efforts and will be submitting a letter to the editor to that effect.

Resident and Community Comment

Yard Sale Ordinance-Paul Delmonico of 144 Prospect Hill Drive

Mr. Delmonico stated that the Yard Sale Ordinance has been in effect for eight years, was rewritten four years ago, and is still not working. He claims that it was written only for him and cited the following figures he obtained from driving through town and counting yard sales in relation to those individuals who pulled permits:

2007-- 349 sales with 222 violations 2008-- 568 sales with 333 violations 2009-- 630 sales with 303 violations

Mr. Delmonico claims that in three years there have been more than 1,000 sales with only five warnings issued by the Police Department. He is proposing that we wither make the ordinance fair or get rid of it.

Councilor Pap noted that this is not the first time Mr. Delmonico has appeared before Council, and he motioned to refer this issue to the Ordinance Committee to revisit. Councilor Whitaker seconded the motion.

Councilor Molisse voiced his disagreement concerning referral.

Councilor Smart is opposed to referral to the Ordinance Committee because he is not in favor of changing the ordinance.

Councilor McDonald stated that the ordinance was put into place for those who habitually held sales every weekend. He feels that the current ordinance is fair and doesn't foresee an amendment.

Councilor O'Connor is opposed to the referral and noted that Mr. Delmonico's figures as stated, indicate improvement over time for offenders. He further noted that this ordinance is in its infancy and it takes time to catch on. People having more than four yard sales per year should consider opening a business.

Councilor Harrington stated that the ordinance is successful and it prohibits an excess of yard sales which effects quality of life for our residents.

Councilor Lacey is not in favor of referral, he understands that Mr. Delmonico does not agree with the ordinance, as is evidenced by Mr. Delmonico's weekly calls to him.

President Mathews will not vote in favor of this referral, although he will support a letter addressed to administration which speaks to enforcement of the ordinance.

On the motion for referral to the Ordinance Committee, the vote was 2-9 (Councilors Pap and Whitaker voting nay)-motion does not pass.

Councilor DiFazio motioned to notify administration in writing of the report of numbers from Mr. Delmonico and ensure that selective enforcement is not occurring, motion seconded by Councilor O'Connor. It was noted that Councilor DiFazio would draft said letter. Roll call vote as follows:

<u>United States Census Bureau Employment Opportunities-Theresa Clark-Recruiting Assistant</u>

Ms. Clarke explained that every 10 years a count of citizens is required by law, and this figure is very important. It determines the number of our representatives in the House of Representatives, in addition to other important factors. The Census Bureau is looking to hire 100 people, with either part time or full time status. The assignment would last from 2-8 weeks with a 20 hour commitment. The time frame is from April to September and the pay is \$18.50/hour for door-to-door census takers, \$14.00/ hour for clerk positions, with a \$.50 per mile travel reimbursement. Workers must be at least 18 years of age and must complete a basic skills test.

It was noted that this is a great opportunity, given the current state of the economy. Interested parties are encouraged to contact the Census Bureau on line at www.2010censusjobs.com or via phone at 1-866-861-2010. Residents are cautioned that all census takers will be displaying an identification badge and will give a statement of confidentiality upon their arrival.

Councilor Conlon commended Ms. Clarke for her presentation and noted the importance of accurate census figures, which determine the distribution of federal funding.

Public Hearings

7:35 PM-09 143-Community Preservation Committee/Whitman's Pond Restoration and Preservation

Councilor O'Connor stated that this measure was advertised on January 15, 2010. Councilor O'Connor motioned to open the public hearing, motion seconded by Councilor Smart and voted unanimously.

Mr. Wilson presented that this measure seeks to raise and appropriate the sum of \$50,875 from the 2010 fiscal year open space set aside account to fund the restoration and preservation of the main body of Whitman's Pond through herbicide weed control. It was noted that the current balance in the CPC account is \$72,600 and further that this was voted unanimously by the CPC.

President Mathews asked if there were comments from the public to which the following gentleman spoke:

Tom Daru, of 333 Columbian Street, Treasurer of theWhitman's Pond Association, spoke in favor of this measure, and is hopeful that the town will secure a grant and stated that this treatment will last for a few years.

Councilor O'Connor motioned to close the public hearing, motion seconded by Councilor Smart and voted unanimously.

7:36 PM-09 144-Community Preservation Committee-Weymouth Housing Authority Window Replacement

Councilor O'Connor stated that this measure was advertised on January 15, 2010.

Councilor O'Connor motioned to open the public hearing, motion seconded by Councilor Smart and voted unanimously.

Mr. Wilson stated that \$110,000 is requested to be allocated as follows: \$69,981 from the Community Housing reserve line item and \$40,019 from the general reserve CPA in order to fund the replacement cost of windows for the Joseph Crehan Housing project for the elderly, at the Calnan and Harrington Circle.

Mr. Clarke stated that the Weymouth Housing Authority approached the CPC at their December 3 meeting and noted that this will allow for an additional building to be fitted with replacement windows.

President Mathews asked if there were any comments from the public, to which there was no reply.

Mr. Moussally, Executive Director of the Weymouth Housing Authority and Robert Fondren, the architect assigned to this endeavor, were available for questions.

A discussion ensued which brought to light that 128 units will be completed with this funding, with an additional 28 units to hopefully be completed when additional monies become available.

It was noted that the Weymouth Housing Authority is encouraged to approach the CPC with additional requests as they develop.

Councilor O'Connor motioned to close the public hearing, motion seconded by Councilor Smart and voted unanimously.

09 146-Reserve Fund Transfer-Extraordinary Repair of Boiler Equipment

It is being requested to transfer \$3,986 from the reserve fund to fund 0002 for the purpose of funding the cost of replacing the hydrotherm block at Town Hall. Councilor O'Connor motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart and voted unanimously.

09 147-Reserve Fund Transfer-Water Department

It is being requested to transfer \$41,399 from the water enterprise reserve fund to pay for certain fiscal 2010 costs associated with the MWRA bond for the new water treatment plant.

Councilor O'Connor motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart and voted unanimously.

10 002- Appointment to the Board of Elder Services-Steve Manupelli

In accordance with section 2-10, the Mayor submits the name of Steve Manupelli of 21 Nanset Road for appointment to the Board of Elder Services-term to expire June 30, 2012.

Councilor O'Connor motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart and voted unanimously.

Mr. Gallagher noted that this measure requests that the Town of Weymouth raise and appropriate the sum of \$4000 from the fiscal year 2010 general reserve fund for purpose of funding the preservation of the main body of Whitman's Pond through enforcement of the conservation restriction for the CPC property located off of Woodbine Road.

Councilor O'Connor motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart and voted unanimously.

10 008- Community Preservation Committee-Preservation of Wall and Gates at Veterans' Memorial Field

Mr. Gallagher noted that this measure requests that the Town of Weymouth raise and appropriate the sum of \$271,000 from the CPC unreserved fund balance for the purpose of funding the preservation of the historic wall and gate at Veterans Memorial Field.

Councilor O'Connor motioned for referral to the Budget/Management Committee, motion seconded by Councilor Smart and voted unanimously.
