Presentation of Fiscal Year 2007 Budget

Mayor David M. Madden and James Wilson, Chief Financial Officer gave a Power Point presentation overview of the FY 07 budget.

The Mayor spoke of his goals and priorities. He stated that it is his intention to maintain current levels of service. He noted that some of the FY 06 items were pre-paid in the FY 05 budget.

The Mayor stated that he had directed Department Heads to include in the FY 06 budget; all raises, as well as expected increases in utility costs. He noted that at the beginning of FY 06 he implemented a hiring freeze on all open positions. All open positions to be filled need to be approved by the Mayor.

Several positions were eliminated; two firefighters, two police officers, two laborers in the Department of Public Works, one staff person in the Collector's Office, and ten positions in the School Department.

All capital requests were evaluated with a focus on building and grounds.

The Mayor noted that the total amount in State aid on which this budget is based is \$26.8 million. The town's total budget is \$121 million. The budget is broken out into fixed costs and operating costs.

Mr. Wilson gave an overview of revenue sources, expenses, and capital improvements.

The Mayor stated that the Town has been unable to put money into the Stabilization Fund.

The Mayor informed those present that \$600,000 in additional State funding will be available and will be used to fund the Superior Officer's contract ,the non-union employee contract obligations, and tuition reimbursement. School materials will also be purchased.

The Mayor stated that his priorities are Education and Public Safety, balanced against other needs.

Public Comment

Susan Peters of 834 Commercial Street requested that any additional Chapter 70 monies received by the Town be returned to the School Department Budget. She stated that the final House budget allows for an additional \$600,000, with \$450,000 coming from Chapter 70. She noted that Chapter 70 money is specifically earmarked for education.

Cathy Torrey of 14 Riverbank Road also spoke to the need to return to the School Department, any additional Chapter 70 monies. Mrs. Torrey stated that recent statistics indicate that Weymouth spends 14% less than the surrounding towns of Quincy, Braintree, and Randolph on education. She expressed concerns regarding the increase in sports fees, and the charging of fees for bus ridership. She stated that she is also concerned about students having to pay for a photography course; and questioned if this practice will be used for other courses. She asked that a commitment be made to the public schools.

Kathleen Curran of 15 Babcock Avenue stated that she believes that the Chapter 70 increase should be returned to the schools.

Cathy Torrey read a statement from another parent, Elizabeth Foster-Nolan, President of the Town Wide Parent Council. Ms. Foster-Nolan, in her written comments, noted that Weymouth lags behind the state average in per pupil expenditures. She noted that under the current budget required textbooks for students will not be available. Also, sports fees will increase and parents of 7th and 8th graders will now have to pay for transportation. Ms. Foster-Nolan urged the Mayor and Town Council to step up to the plate and show that they do want Weymouth Public Schools to be able to create a supportive learning community which results in high achieving lifelong learners who actively contribute to society. She noted that this is the Weymouth Public School's Mission Statement.

Mayor Madden stated that by spending the \$600,000, this will free up \$400,000 from free cash by paying for FY 07 operating expenses. He stated that the leadership of this town supports education.
