## SOUTHFIELD IMPACT


- Responses to Southfield shift FD resources and leaves the rest of Weymouth vulnerable.
- WFD staff resources are being diverted.
  - Chief
  - Fire Prevention
  - Training
  - Inspections

# SOUTHFIELD IMPACT

- Southfield is not a conventional development
  - Narrow streets and alleyways
  - Minimal setback
    - (3' lot line/ 6' to neighboring home)
  - High density population
  - City like design
- Responses to Southfield have increased over 300% from 2009-2013

### **CURRENT FIRE COVERAGE**

- Station 1- 195 North Street
- Station 2- 636 Broad Street (closed 2008)
- Station 3- 138 Winter Street
- Station 5- 246 Park Avenue
- 3 engines / 1 ladder/ 17 minimum per shift
- 88 members in the fire suppression force
- 6,500+ emergency responses a year

# WFD 3 Engines / 1 Ladder (15 FF)

#### **Engine Co. Duties**

- Est. Primary and Secondary Water Supplies
- Advance various hose lines
- Supply auxiliary appliances
- Locate, Confine, & Extinguish the Fire
- Protect Life Hazards
- Protect exposures
- Put the fire out!




- Position ground/aerial Ladders
- Force Entry
- Primary & Secondary Searches
- Rescue
- Ventilation (Horizontal, Vertical)
- Utility control
- Salvage & Overhaul



### PRE 1990


- Weymouth operating 4 stations with 5 engines,2 ladders, and a squad.
  - 132 member department
- NAS South Weymouth (Southfield) was protected by a separate Federal Fire Department.

- 48 member department.




### WFD STAFFING

- In 1996 there were **117** uniformed members
  - 4,688 emergency service calls
  - 338 Fire/Explosion
- In 2004 there were 100 uniformed members
  - 6,731 emergency services calls
  - 420 Fire/Explosion
- In 2013 there were 86 uniformed members
  - 6,824 emergency services calls
  - 308 Fire/Explosion

Every year we are being asked to do more with less.

### **RESPONSE TIMES**

 A critical factor in the effectiveness of any emergency response agency is the ability to get personnel and equipment to the scene of the emergency in a timely manner.



### **RESPONSE TIMES**

• The most widely recognized standard used in response time analysis is **NFPA 1710.** 



### **RESPONSE TIMES**

• NFPA 1710:

The fire department's fire suppression resources shall be deployed to provide for the arrival of an engine company within a 4 minute travel time to 90% of the incidents.



### IMPORTANCE OF RESPONSE TIMES

 Response times <u>do</u> affect the number of lives saved and reduce property loss.




### IMPORTANCE OF RESPONSE TIMES

 More people can be helped or the incident can be mitigated when emergency personnel arrive with in a timely manner.




### **RESPONSE TIMELINE**

**CONFINED TO ROOM OF ORIGIN** 



# Putting the Fire Out



- E1 First line to the fire
- E2 Establish water supply, back up first line
- E3 RIT
- L1 Search/Vent open roof, utility control, etc.
- C2 Incident Commander

### LEGISLATION IMPACT

- In the fall of 2012, Tri-Town hired fire protection consultant, former Boston Chief Kevin MacCurtain, to study and make recommendations on future fire protection at Southfield.
- This report recommended:
  - Immediate hiring of a fire inspector.
  - Purchase and staffing of a new engine FY 13.
  - Design and building of a new fire station FY 15.

### This has not happened to date! Will it happen if legislation passes?

### LEGISLATION IMPACT

- Immediate increase in plan reviews for Fire Prevention.
- Town of Weymouth will be responsible for the fire protection of Southfield.
- How will we deal with existing vacant properties?

### NEEDS

- To improve response times with the safety of Weymouth residents and firefighters in mind as well as the future residents of Southfield, the following are the WFD's needs:
  - -Build a new fire station (4.5 million)
  - -Purchase new fire engine (\$650,000.00)
  - -Purchase new ladder (\$900,000.00)
  - -Purchase new forest truck (\$60,000.00)
  - -Hire 33 new personnel (3.3 million annually)

## NEEDS FY 15

Looking at Southfield as a newly developed community the minimum starting point for fire protection is the following:

- Station
  - \$2- \$4.5 million
  - \$50,000 annually for utilities and maintenance upkeep
- 1 Engine
  - \$650,000.00
- Personnel to man the engine
  - 23 firefighters at \$2.1 million annually

## NEEDS FY18

With anticipated growth and commercial development the following may be required:

- Ladder truck
  - \$1 million
- Personnel to man the ladder
  - 10 firefighters at \$1 million annually
- Forest truck
  - \$60,000.00

### SUMMARY

- When responses take more than a few minutes, losses escalate substantially, resulting in a greater loss of life and property.
- The only solution to achieve quicker response times is to locate an Engine closer to the Southfield property.

### SUMMARY

- WFD needs are consistent with minimum staffing levels per NFPA 1710.
  - 4 personnel per apparatus
  - Arrival time in 4 minutes
- The needs of the WFD do not change regardless of the status of the legislation.
  - People are living there currently and we are asked to protect them.
