

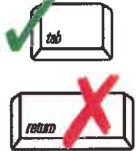

Narrative for Project at 228 Idlewell Boulevard

Driveway Project (480 sq ft)

We would like to add a driveway, as we currently do not have a driveway to enter onto our property. The location of the driveway would be on the northwest side of the property, which is currently composed of dirt, and is unable to grow grass. Simultaneously, this area is also on a steep slope, which creates rain run off down to the cove during inclement weather. The proposed gravel driveway creates a more level area with a natural rock retaining wall at the end of the driveway, and would allow for better drainage and a more stable ground.

Shed/Retaining Wall/ Patio Project Replacement (720 sq ft)

The current shed is located in the 25 foot zone. This shed stores a lawnmower, generator, yard tools, etc. The proposed new shed would be located between 80 and 100 feet from the water line, and 5 feet higher in elevation.

The new retaining wall would replace the old concrete wall. This new wall is made of heavy duty structural interconnecting blocks, measuring 2'x2'x4'. This wall will have a strong back weight from the street and hill above, as the current condition of the concrete wall is unable to hold back properly. Pre-cast structural blocks were chosen for the new retaining wall because they are less invasive to install. With these pre-cast blocks, there is no need for concrete forms, concrete trucks, or the pouring of concrete.

The patio is being replaced and the area is being made longer in order to accommodate for the new shed. The ground will be covered with gravel under the shed, and patio pavers on the rest of the area. We will be replacing the old pavers.
