Fencing is considered a minor activity and not subject to a Notice of Intent provided that: (1) during construction, efforts will be made to reduce adverse impacts on the wetland, and, after construction, efforts will be made to stabilize disturbed areas. (2) after construction, the fence will not constitute a barrier to wildlife movement, stonewalls or stacks of cordwood.
