The Nationalgrid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways and places of the **Town of Weymouth** and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 700 feet more or less of 4 inch, 60#, gas main in Summer St., Weymouth, from existing 2 inch 60# gas main in Homestead Ave., southwesterly to Rucille Ave. Including a 4 inch stub to cross the street to serve Lester Ln. To prepare for the future removal of the regulator in Summer St. at Rucille Ave.




