SUBJECT: TECHNICAL AMENDMENT TO DEPARTMENT OF ASSET
MANAGEMENT ORDINANCE
DATE: April 12, 2018

This measure comes before Council to amend the newly added ordinance language creating the Department of Asset Management.

On April 2, 2018, the Council unanimously voted unfavorable action on Measure 18-012, the Acceptance of GL. c. 71, §37M. That same night, Council unanimously approved Measure No. 18-011, the Reorganization Plan Establishing the Department of Asset Management.

The amendment is necessary due to the passage of the reorganization plan creating the new department, but the Council's rejection of acceptance of GL. c. 71, §37M. The amendment strikes the reference to that statute from the paragraph as discussed during the Council hearing that night.
