I submit the following measure to Town Council for its consideration and action:

Chapter 3 of the Town of Weymouth Ordinances is hereby amended by adding the following new section: —

3-336 Department of Asset Management, Director of.

- (a) Establishment. The department of asset management shall be under the direct control and supervision of a director of asset management who shall be appointed by and who shall be under the general direction of and be responsible to the mayor, the superintendent of schools, or their designees. the director of asset management shall serve for an indefinite term. the director of asset management shall be a person especially fitted by education, experience, and training to perform the duties of the office.
- (b) Powers and duties. The director of asset management shall be responsible for the supervision and coordination of all activities of the department of asset management in accordance with state and federal statutes, Town ordinances, rules and regulations.

This measure comes before Council to amend the Ordinances creating a Director for the newly-formed Department of Asset Management.

On April 2, 2018, the Council unanimously approved Measure No. 18-011, the Reorganization Plan Establishing the Department of Asset Management. That measure added to chapter 4 of the Town of Weymouth Ordinances a new department.

The amendment is necessary because the passage of the reorganization plan creating the new department neglected to include an ordinance creating director's position in chapter 3 of the Town of Weymouth Ordinances.
