In July of 2019, the Town of Weymouth joined the Lawsuit Against Opioid Defendants, which include several manufacturers and distributors of opioids.

These defendants distributed millions of opioids in the Town of Weymouth and surrounding areas throughout Massachusetts, overwhelming our community.

They dispersed the equivalent of between 15 to 45 oxycodone pills for every Weymouth resident between 2010 and 2016.

This resulted in an increase in opioid-related overdoses in Weymouth, including one case in January 2018 when a two-year-old girl was taken to Boston Children's Hospital for ingesting a synthetic opioid pill.

In 2015, Weymouth's first responders received 183 calls due to opioid-related overdoses. In 2016, those numbers increased to 219 calls. In 2015, opioid related deaths claimed 24 lives in Weymouth. In 2016, this number increased to 38 opioid-related deaths.

In 2021, the settlement of claims against the nation's three largest drug distributors and drug maker Johnson & Johnson was reached, providing hundreds of millions of dollars to address the opioid crisis across the state.

In 2022, other settlements were also reached

40% of the settlement funds are going to Massachusetts Cities and Towns, including Weymouth. Our allocation is 0.556%.

Abatement Funds must be used to supplement and strengthen resources for prevention, harm reduction, treatment and recovery.
